NOTICE OF DOCUMENTS ADDED TO THE RULEMAKING FILE

NOTICE IS HEREBY GIVEN of modifications to the originally proposed regulatory text in Chapter 6, Division 2 of Title 3 of the California Code of Regulations for the Department of Food and Agriculture (Department), Animal Health and Food Safety Services, Animal Health Branch. The proposed modifications pertain to the originally proposed regulatory text as stated in the Informative Digest published in the California Regulatory Notice Register on April 19, 2019 [Notice File No. Z2019-0404-01, Register 2019, No.16-Z] relating to the Department's regulations for Equine Medication Monitoring Program - Fees. The Department is now providing notice of proposed modifications to the regulation text which is changing for consistency purposes and is enclosing a copy of the modified text.

NOTICE IS HEREBY GIVEN of documents added to the rulemaking file related to the action described above (California Regulatory Notice Register 2019, No. 16-Z). The Department is adding to the rulemaking file three (3) forms which are currently incorporated by reference in the existing regulatory text of section 1280.1 (and referenced in section 1280.8) and a Supplement to the Initial Statement of Reasons (ISR) pursuant to Government Code sections 11346.8(d), 11346.9(a)(1) and 11347.1. The Department is adding three (3) forms [Application to Register Equine Event/Assessment Report for Registered Events, Form 76-024A (Rev. 08/19), Official Form for Declaration of Drugs Administered, Form 76-027 (Rev. 08/19), and Saleyard Assessment Report/Law Prohibiting Drugging of Horses, Form 76-025 (Rev. 08/19)] to the rulemaking file to update existing forms for consistency with the proposed regulatory text. The purpose of the Supplement to the ISR is to clarify the intent of the forms added and amended regulatory text inadvertently omitted from the original proposal as shown in italics. The Supplement to the ISR and the three (3) forms are available for public inspection at the Animal Health Branch located at 2800 Gateway Oaks Drive. Sacramento, California, from August 24, 2019 and ending September 9, 2019, between the hours of 8:00 a.m. and 5:00 p.m. The Department is enclosing a copy of Supplement to the ISR and the three (3) forms with this notice; any additional copies may be obtained by contacting the person named in this notice.
