Re: Petition to Terminate Quota Implementation Plan

Dear Secretary Ross,

This firm serves as legal counsel to the coalition of dairymen seeking to terminate the Quota Implementation Program (the "Plan"). This letter is being sent on behalf of Eugene Azavedo, as the named petitioner, for the purpose of submitting a petition signed by the requisite number of market milk producers in favor of terminating the Plan (the "Petition").

The Petition is being submitted in accordance with Section 1103 of the Plan, which provides that "upon receipt of a petition signed by at least 25 percent of market milk producers regarding the amendment or termination of this Plan, the Secretary shall convene the Producer Review Board to review the merits of the petition and make recommendation to the Secretary. If the Secretary finds that the Plan no longer tends to effectuate the purpose intended, termination *shall* be submitted for referendum in the same manner as provided for its initial approval." (Emphasis added.) Pursuant to emergency legislation that was adopted by the legislature in 2017, the Plan was approved by a statewide referendum of producers conducted pursuant to Sections 62716 and 62717 of the California Food and Agriculture Code. (*See Food & Ag. Code*, §62757.)

The enclosed Petition is signed by 285 market milk producers. In addition to providing copies of the signed Petition, we have also enclosed a spreadsheet listing each of the names of the producers who have executed the Petition to terminate the Plan for ease of reference. Based on the number of signatories to the Petition, we have exceeded the twenty-five percent (25%) threshold prescribed by the Plan when compared against the latest producer list dated January of 2019, which was provided by the Plan Administrator, Donald Shippelhoue. Accordingly, the applicable statutory provisions mandate the preparation of a ballot for submission to all eligible producers in the State seeking their individual vote as to whether the Plan shall be terminated. (*See Food & Ag. Code*, §62717.)
