(1) CALL TO ORDER

(4) DEPARTMENTAL UPDATE

The Secretary also participated in the ‘Don’t Pack a Pest’ press conference in partnership with USDA/APHIS. Other items included updates on CDFA’s Climate Smart Agriculture programs and upcoming announcements on Healthy Soils Program and Alternative Manure Management.
