Southern District

Delimitation Treatment and Survey

- Orange County:
 - Anaheim 15, Garden Grove 53 & 55, Santa Ana 49 – 56, Fountain Valley 1, and Orange 28 - 31
- Los Angeles County:
 - Paramount 1 & 2, La Mirada 5, Pico Rivera, and Whittier 35
- San Bernardino County:
 - Retreatments in Montclair, Ontario, and Colton will start by end of March/early April
- Riverside County:
 - Corona 6 & 7, Moreno Valley 1
- San Diego (Fallbrook):
 - Completed survey and treatments at 78 properties
 - All samples negative and no new finds

Areawide treatments – Winter Cycle Tempo Only (Mid Dec 2020 thru March 2021)

- Completed in Santa Barbara, Borrego Springs, San Pasqual, and Imperial County
- Continues in Ventura, San Bernardino, Hemet, Coachella, US/MX Border Buffer (SD and Imperial)

- Risk-based Survey Cycle II

- The second cycle of risk-based survey has been completed in Orange and Imperial Counties
- Riverside and San Bernardino County roughly 85% completed, anticipated completion by mid February
- The Los Angeles and San Diego County has completed between 77 - 80%, anticipated completion by third week of February

- Two-mile Border buffer risk survey 2021 Winter Cycle (Dec 22, 2020 – March 21, 2021)

- Completed 26% in San Diego and 53% in Imperial County

- Quadrant Samples in Nov/Dec/Jan (Find Sites / Adjacent / Inconclusive)

- Orange County 792
- Los Angeles 655
- Riverside 94
- San Bernardino 93
- San Diego 52

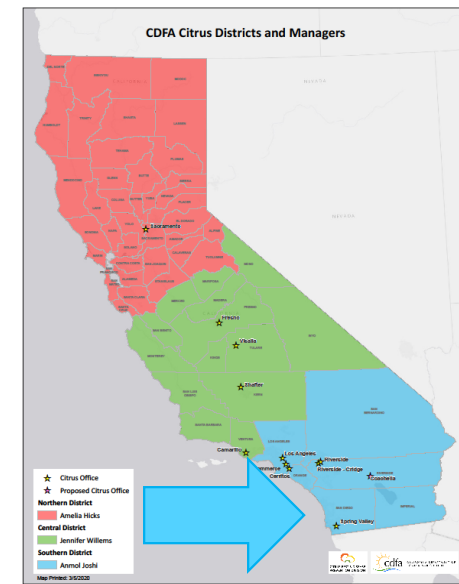

Central District



- **New ACP Detection**

- Exeter, Tulare Co. at the Exeter Specialties Packing House on February 3, 2021
 - 1 adult on a trap along fence line of the facility
 - CDFA conducted 50 m visual survey with no further ACP detected
 - Reported as a regulatory incident

- **Detection trapping**

- On-going for Fresno and Madera Counties

- **Delimitation trapping**

- On-going for Kern County
 - CDFA services 345 traps
 - Kern County services 2,273 traps

- **Treatment**

- Kern Co. treatment project is winding down. Expecting to complete treatment by mid-to end of Feb.



Northern District



Contra Costa County (Pinole)

- Adult ACP confirmed on November 25, 2020
- Treatment completed on December 23, 2020
- Delimitation trapping occurring in 4 grids
- No additional detections

Santa Clara County (San Jose)

- Final treatments occurred on November 30, 2020
- Delimitation trapping occurring in 18 grids
- One detection since January 13
- Monthly biocontrol releases



HLB Risk Survey

- Cycle 2 (2020) concluding in February
- Survey is occurring throughout 20 counties

ACP Detection

- Winter residential trapping continues in 20 counties
- Year-round County trapping continues in 3 counties

ACP Treatment

- No active treatment projects
