This is in response to your November 22, 2000, letter and enclosures about the authority of state and county officials to inspect meat and poultry products for quantity in federally inspected establishments.

As you know, we like to work closely with state and local officials whenever possible. However, in this matter, California is preempted by Federal statute from conducting weights and measures of product in federally inspected establishments. Under the Federal Meat Inspection Act, product within federally inspected establishments falls within the jurisdiction of the Food Safety and Inspection Service.
