Agriculture is a major industry for the Golden State. With 69,400 farms and ranches, California agriculture is a \$50 billion industry that generates at least \$100 billion in related economic activity. The California Department of Food and Agriculture's (CDFA) mission is, "to serve the citizens of California by promoting and protecting a safe, healthy food supply, and enhancing local and global agricultural trade, through efficient management, innovation, and sound science, with a commitment to environmental stewardship."

CDFA is the lead agency for international policies and programs related to California agriculture. CDFA coordinates with other state agencies; California's agricultural marketing programs (agricultural marketing orders and commissions); Visit California; the California Centers for International Trade Development (California Community Colleges Chancellor's Office); and other stakeholders to provide programs and services to California businesses.

CDFA is a founding member of the Western United States Agricultural Trade Association (WUSATA) a non-profit state regional trade group that promotes U.S. food and agricultural exports. The association receives federal funding and works in cooperation with the U.S. Department of Agriculture, Foreign Agricultural Services to support state sponsored trade activities and administer market development programs for private companies.

Applications are accepted year-round, but a current application deadline for the Winter session (Beginning Feb/March 2020) is **January 3rd**. Interviews will take place in Jan/Feb and the internship will start in Feb/March and conclude prior to January 2021. Interns will be paid \$15.00 per hour, up to 40 hours per week – total compensation cannot exceed \$12,000 in the calendar year.
