**TO REGISTERED SERVICE AGENCIES****SUBJECT: TESTING SCHEDULE FOR SERVICE AGENT LICENSES**

On January 1, 2001 California Business and Professions Code Section 12540 required service agents to obtain a license and, before servicing any commercial measuring equipment, to be employed by a service agency. Licenses obtained at that time are nearing their expiration dates. Licensed agents needing to renew before January, can make arrangements with any county office up to 60 days before license expiration. This will ensure that eligibility to service commercial devices will not be interrupted. Some counties conduct testing more frequently than others so it may be beneficial to contact more than one county regarding their examination schedules.

Many counties will be able to schedule examinations with local service agents on request. Some counties also provide training in conjunction with particular testing dates. A contact list for county offices is enclosed. A Service Agent Examination Study Guide may also be viewed and/or downloaded from the Division of Measurement Standards website at:

Service Agents should have a general knowledge of Division 5, Chapters 5 and 5.5 of the California Business and Professions Code and Title 4, Division 9, Chapter 4 of the California Code of Regulations.

The fee to take the exam is \$35.00 per service agent and picture identification must be presented. A renewal license will also require a current license number, though this can be verified for applicants as long as the required identification is presented.

This is also a good opportunity for each agency to review licensed agents in their employment to make sure all registration information is complete and up to date.

To accommodate the large number of Southern California service agents whose current license will be expiring, a series of coordinated training seminars/testing will be offered by Southern California Weights and Measures officials. Below is a schedule, by county, of dates and times the seminars/testing will be offered. Please note contact persons and phone numbers for reservations for these scheduled exams. Reservations are required; "walk-ins" will only be permitted if space is available.
