SUBJECT: Settlement – Contain-A-Way, Inc., a Delaware Corporation

Enclosed is a copy of the Final Judgment Pursuant to Stipulation issued against Contain-A-Way, Inc., a Delaware Corporation. The case was filed on September 29, 2015, by the District Attorney's office of Santa Cruz County in conjunction with the District Attorneys' offices of Contra Costa, Fresno, and Sonoma for failure to have scales sealed prior to use, failure to locate or position a weighing device used in retail trade in such a manner that consumers could not read the indications, and purchasing in less than true quantity CRV materials in violation of California Business and Professions Code Sections 12501.1, 12510, and 12512 respectively.

The California Department of Food and Agriculture, Division of Measurement Standards (Department) worked with weights and measures investigators from over 27 counties on this case. The total settlement was for \$285,000. Civil penalties amounted to \$92,525, agency costs were \$177,474, and \$15,000 of cy pres restitution was paid to the Department to conduct a product verification survey.

Santa Cruz County should report these penalties on the County Monthly Report. All participating counties should separately record their individual investigative cost reimbursements in the appropriate columns on the report.

The Department appreciates the fine work done by the District Attorneys' Offices along with the state and county investigators that documented and caused to be prosecuted these violations. 26 THE PEOPLE OF THE STATE OF CALIFORNIA has filed its complaint and appears
27 through its attorneys: JEFFREY S. ROSELL. District Attorney for the County of Santa Cruz,

4 and MARK A. PETERSON, District Attorney for the County of Contra Costa, by Deputy
5 District Attorney Steven J. Moawad. Defendant Contain-A-Way, Inc., a Delaware corporation,
6 appears by and through their attorneys McKasson & Klein LLP by Neil B. Klein, Esq. All
7 parties waive their right of appeal, the agreed presumption set forth in Civil Code section 1654
8 is not applicable and there is no presumption that documents should be interpreted against any
9 party.

10 This court having considered the pleadings and the Stipulation for Entry of Final
11 Judgment and good cause appearing therefore;

12 IT IS HEREBY ORDERED, ADJUDGED AND DECREED, THAT:

13 **JURISDICTION**

14 1. This court has jurisdiction of the subject matter hereof and the parties hereto.

15 **NO ADMISSION OF LIABILITY**

16 2. This Judgment is not to be construed as an admission of liability by any party.

17 This Judgment was entered into as a result of a stipulation of the parties, without admissions of
18 fact or law, and without any admission by the Defendant of liability, wrongdoing, illegality, or
19 of any fact alleged in the Complaint.

20

21 **APPLICABILITY**

22 3. This Final Judgment is applicable to defendant Contain-A-Way, Inc., a
23 Delaware corporation, and to its agents, servants, employees, officers, directors,
24 representatives, successors, assignees, and to any and all persons, partnerships, corporations,
25 and other third party entities acting under, by, through, on behalf of, or in concert with
26 Defendant, with actual or constructive knowledge of this Final Judgment, including, but not
27 limited to, rePlanet Holdings, LLC (hereafter collectively referred to as "Defendant(s)"). This

1 Final Judgment is also applicable to any and all subsidiaries and divisions of the Defendants
2 and their respective officers, representatives, successors, assignees and all persons,
3 partnerships, corporations, and other entities acting under, by, through, on behalf of, or in
4 concert with any such subsidiary with actual or constructive knowledge of this Final Judgment.

5
6 **INJUNCTION**

7 4. Pursuant to Business and Professions Code sections 17203 and 17535,
8 Defendants are permanently enjoined and restrained from violating Business and Professions
9 Code sections 12501.1, 12512, 12510, 17200 and 17500 related to the weighing of recyclable
10 materials in California.

11 5. Pursuant to Business and Professions Code sections 17203 and 17535,
12 Defendants are hereby ordered and mandated to do all of the following:

13 A. TARE TO ZERO PROGRAM WITH CAVEAT FOR ROLL OUT.

14 Develop and implement a procedure for the weighing of recyclable materials to be used at all of
15 its recycling centers. This system, hereinafter referred to as "Tare to Zero," shall require that
16 the employee weighing the customers' recyclable materials take a tare for the container used in
17 each individual consumers transaction. The system shall require that each weight
18 determination start with an empty barrel and the setting of the "tare" to the weight of that
19 barrel. The recyclable materials shall be then added to the barrel and the barrel weighed again,
20 providing the gross weight. The system shall then calculate the difference between the gross
21 weight and tare weight to accurately record the net weight of the recyclable materials. The tare
22 to zero system shall be fully implemented no later than sixty (60) days after the entry of the
23 Stipulated Final Judgment at all recycling centers set forth on the attached Exhibit A. Any and
24 all new recycling centers operated by Defendants after the effective date of this Final Judgment
25 shall also fully implement the tare to zero system. Defendant shall provide annual training to
26 its employees regarding compliance with the Tare to Zero Program.

27 B. SECRET SHOPPER PROGRAM. Develop and implement an internal
28

1 “secret shopper” program to increase the quality of the consumer experience at Defendants’
2 recycling centers. This program must include methods to monitor and ensure that (1) tare is
3 taken in every transaction for the specific container used by each consumer; (2) that the Tare to
4 Zero program is being followed; (3) that the weighing devices and/or weighing instruments
5 used at the Defendants’ recycling centers have been sealed by a sealer prior to being placed in
6 operation; (4) that the weighing devices and/or weighing instruments used at the Defendants’
7 recycling centers are accurate and have been recently calibrated; and (5) that the Defendants’ do
8 not compensate a consumer for a quantity of recyclable materials that is less than the true
9 quantity. The Secret Shopper program shall consist of a minimum of one (1) Contain-a-way
10 Inc. employee who brings recyclable materials to a site and has it processed just as a regular
11 consumer would. During the visit the secret shopper shall test for accurate weighing procedures
12 and accurate weight. All recyclable materials shall be pre-weighed by the secret shopper before
13 taking to the recycle site. If the weight of any recyclable materials at the site varies by more
14 than 0.10 lbs. per weighing bucket or basket, an immediate email shall be generated to the
15 Defendant’s corporate office. If a site fails it shall be retested a minimum of one (1) time within
16 thirty (30) days. All sites set forth in the attached Exhibit A, and any and all new recycling
17 centers operated by Defendants after the effective date of this Final Judgment, shall be secret
18 shopped a minimum of one (1) time per year.

19 C. Defendant shall maintain all records of the Secret Shopper Program for
20 at least 12-months after expiration of a prior calendar year (e.g. all records for 2015-2016 shall
21 be maintained until December 31st 2017) no less than a period of one calendar year from the
22 date of creation. These records shall be made available to any District Attorney, City Attorney,
23 any authorized representative of the State of California Division of Measurement Standards, or
24 any representative of the County Sealer or Director of a County Agricultural Commissioner at a
25 reasonable time and place upon reasonable written notice.

26 D. TECHNOLOGY. Purchase and implement technology which will
27 electronically connect the scales at Defendant’s recycling centers, as set out in Exhibit A
28

1 attached, to point-of-sale devices. This technology shall automatically electronically capture
2 and record weights, and other relevant data, measured at the scale such that the information will
3 no longer be required to be recorded by an employee. This technology shall be implemented at
4 all sites set forth in the attached Exhibit A within one (1) year after the entry of this Final
5 Stipulated Judgment. Any and all new recycling centers operated by Defendants after the
6 effective date of this Judgment shall implement this technology within a reasonable time.
7 However, if Defendant is unable to implement the technology within one (1) year, prior to the
8 expiration of this period, it may apply to the Plaintiffs for additional time to do so.

9 E. Defendant shall specifically advise the following persons of the
10 injunctive provisions of this Final Judgment to: (a) its current members, officers and directors;
11 (b) any members, officers or directors who are appointed or elected while the injunction
12 (paragraph 4) is in effect, and (c) any and all persons responsible for the management (a) the
13 weighing of recyclable materials that are offered for sale in California to California consumers
14 and (b) training personnel that operate weighing devices at the Defendant's recycling centers
15 during the 60-months (5 years) that follows the date of entry of this Final Judgment.

16 F. Defendants shall make available and fully and clearly explain the
17 Injunction in this Final Judgment, including the terms and conditions thereof, to each person or
18 entity responsible for purchasing recyclable materials from consumers. At any time after
19 expiration of the 60-months from date of entry of Judgment, Defendant may request that the
20 Court order termination of this Injunction, provided written notice thereof is served on the
21 People 30-days prior to such request.

22 MONETARY PROVISIONS

23 6. **Costs.** Defendant shall pay the People as and for investigative costs the sum of
24 One Hundred Seventy-Seven Thousand Four Hundred Seventy-Four Dollars and Forty-One
25 Cents (\$177,474.41) pursuant to Business and Professions Code section 12015.5, by separate
26 certified checks made payable to each agency in the corresponding amounts listed below.
