THE ANIMAL CARE PROGRAM



This brochure is for California Farmers' Market vendors selling their shell eggs*, whole pork meat* and whole veal meat* from animals on their farms*.

California's Prop 12 (2018) and Animal Confinement Regulations* apply to you and your business operation.

WHAT DO I NEED TO DO AS A FARMERS' MARKET VENDOR?

1.) REGISTER WITH CDFA'S ANIMAL CARE PROGRAM

Distributors* are required to be registered with the California Department of Food and Agriculture (CDFA). Registration is renewed every twelve months.

2.) OBTAIN A CERTIFICATE OF COMPLIANCE*

Egg, Pork and Veal Producers* and Distributors* are required to have a valid Certificate of Compliance by January 1, 2024.

FREQUENTLY ASKED QUESTIONS

What animals are covered under Prop 12 (2018)?

- Egg-Laying Hens*
- Breeding Pigs*
- Calves* for Veal

Is there a minimum flock or herd size of covered animals at a farm to fall under regulatory requirements?

 No, Prop 12 (2018) applies to all covered animals, regardless of flock or herd size.

As a Prop 12 (2018) certified producer, do I need to display my Certificate of Compliance at a Farmers' Market?

 No, the best practice is to keep a copy of your Certificate of Compliance available upon request.

As an egg or pork producer, do I still need to complete all other required registrations and inspections for California and/or USDA?

 Yes, the Certificate of Compliance is an additional requirement to sell Covered Product*.

Is there a fee to register as a distributor with CDFA?

 No, there is no fee to register as a distributor. The registration is required to be renewed every twelve months.

How much does certification cost?

 Distributor and/or producer certification cost is determined between the certifying agent and the distributor* and/or producer. FIVE HEN SPECIES ARE INCLUDED
IN THE COVERED ANIMAL
REGULATIONS FOR EGGS. SCAN
