# (3) Program Updates

# Financial Update

Ms. Katie Hatch presented on the information requested by the advisory committee at the September 2020 meeting. For events held from July 1, 2019 to July 31, 2020, there are forty-three (43) events that have not submitted their

testing fees to EMMP yet. Twenty-four (24) of those events occurred in 2019 and were sent letters and were called by EMMP staff to remind them of fees due. The other nineteen (19) events were held in 2020 and either had a letter already sent to them or there is one drafted to send. There are some managers who have multiple unpaid events and EMMP staff request the assistance of the advisory committee members to get in touch with the event managers in their respective disciplines to encourage them to submit their testing fees in a timely manner. Program will send EMMP Advisory Committee members a list of managers and events with unpaid fees.

Ms. Hatch also presented the data analysis regarding the costs of urine sampling vs. blood sampling. Information was calculated using the data from 2015-2019 shows and rides (excluding sales) and included the average number of samples per event, the cost of the veterinarian to pull blood samples (when applicable), the laboratory testing costs, the time for inputting the records of sample collection in the office, as well as the costs of tester hours and distance traveled. The total cost per urine sample (when two samples were collected per event) was \$186.87 while the total cost per blood sample (when ten samples were collected per event) was \$150.92. When increasing the number of urine samples collected per event to three per event, the cost per sample decreased to \$159.11. There is a variance between testers on the number of urine samples collected so EMMP staff will work with the testers to increase the number of samples collected per event. The committee agreed to the most cost-effective and comprehensive plan recommended by the Program, which is to continue both urine and blood sampling as the cost per sample (when three urine samples vs ten blood samples were collected) was not significantly different and a veterinarian is not available for some events the Program would like to test. Therefore, Program recommends testing only 25% of events but utilizing both urine and blood testing.

The committee also discussed the laboratory costs for testing and research. The current cost for EMMP per sample tested at the California Animal Health and Food Safety (CAHFS) Laboratory is \$100 per sample. This rate has been agreed upon for the 2020-2021 fiscal year and the 2021-2022 fiscal year. The rate per sample will likely increase in July 2022. The research projects cost \$36,000 per year and the contract is for two projects per fiscal year. The committee discussed the importance of the research performed and would like to see it continue moving forward. The committee will discuss the plan for research projects at the next advisory committee meeting.

#### **Legal Update**

Dr. Emily Nietrzeba discussed the regulation packet to increase the testing fees to \$14 effective January 1, 2022. She has spoken with the analyst for regulation changes and has started the regulation change process EMMP will be notifying the advisory committee when the packet has been moved forward to encourage

distribution, comments and feedback. The earliest this is likely to happen is late December 2020 or early January 2021.

No new items were discussed. The next meeting is planned for Wednesday, February 24, 2021 from 10am-2pm to be held via Zoom.
