

## Notice of Required Action (Pursuant to Quarantine) Attachment C: Movement of **Calves from HPAI Infected Dairies Requirements**

Quarantined premises will be required to adhere to the following restrictions and conditions for movement:

#### Biosecurity measures for HPAI-infected dairies (farm of origin for calves):

- ALL newborn calves must be fed pasteurized colostrum or colostrum replacer at farm of origin.
- ALL calves held longer than 24 hours at farm of origin must be fed pasteurized milk or milk replacer while at the farm (pasteurized bulk tank milk preferable, if possible).
- The inside of calf trailers must be Cleaned and Disinfected (C&D) with an appropriate HPAI labelled disinfectant prior to arrival at farm of origin.
- The exterior of the calf trailer and trucks must be C&D with an appropriate HPAI labelled disinfectant upon arrival at farm of origin and upon exit (wheels, wheel wells and undercarriage).
- ALL movement must be direct to ranch/single pick-up transport. Pickup from affected dairies must be the last stop of the day.

### Biosecurity measures for calf depots receiving calves from HPAI-infected dairies:

- The calf ranch/depot must follow the above protocol for infected dairies and in addition:
  - o ALL calves at calf depot must be fed pasteurized milk or milk replacer while at depot regardless of farm of origin.
  - Calf depot personnel must conduct daily Active Observational Surveillance (AOS) on incoming groups of calves while at the calf depot. The veterinarian of record must be notified within 24 hours of clinical signs associated with HPAI in livestock.
  - Bedding from trailers must be disposed of in an area away from other calves and livestock.
  - o The inside of the calf trailers must be completely C&D with an appropriate HPAI labelled disinfectant at a location away from calves and livestock, and run-off must be diverted away from livestock pens.

## Biosecurity and surveillance measures for calf ranches receiving calves from **HPAI** infected dairies and calf depots:

- The exterior of the calf trailers and trucks must be C&D with an appropriate HPAI labeled disinfectant upon entry and exit (wheels, wheel wells and undercarriage).
- Bedding from trailers must be disposed of in an area away from other calves and livestock.

- The interior of the calf trailers must be completely C&D with an appropriate HPAI labeled disinfectant at a location away from calves and livestock, and run-off must be diverted away from livestock pens.
- Calf ranch personnel must conduct daily Active Observational Surveillance
  (AOS) for 30 days on incoming groups. Veterinarian of record must be notified
  within 24 hours of clinical signs associated with HPAI in livestock. For California
  premises, a full list of HPAI labeled disinfectants approved for use in California

The requirements listed herein do not waive the standard requirements outlined in Food and Agricultural Code or the California Code of Regulations for the population animals described on the Notice of Required Action.
