

**TITLE 3. FOOD AND AGRICULTURE**  
**ANIMAL BLOOD BANK PROGRAM - PROPOSED REGULATIONS**  
**SECOND 15-DAY NOTICE OF MODIFIED TEXT**

**NOTICE IS HEREBY GIVEN** that the Department of Food and Agriculture (Department), Animal Blood Bank Program, is proposing to further modify the originally proposed text for the California Code of Regulations Title 3, Division 2, Chapter 8 heading, and new Articles 1 – 4 (commencing with section 1303) pertaining to Animal Blood Bank requirements as described in the California Regulatory Notice Register on February 2, 2024, Register 2024, No. 5–Z, Notice File Number Z2024-0123-02.

The portions of the originally proposed text that were modified during the initial 15-Day notice of modifications to the proposed text are indicated by a double underline or ~~double strikethrough~~. Only the sections of the proposed text indicated by **bold underlined italics** or ~~**bold strikethrough**~~ have been modified. The remainder of the text is the same as the originally proposed text. The text of the regulation with the proposed modifications is enclosed.

**Summary of changes to the second modified text:**

§ 1304.1(d)-(g) re-lettered to correct typos in the first modified proposed text.

§ 1306.3, struck “licensed” and added “with products registered” to clarify that all blood banks with product registered with the Department shall pay the proposed fee.

§ 1306.4 corrected a typographical error in the Food and “Agriculture” Code to read Food and “Agricultural” Code since that is the correct title of the Code.

§ 1306.4(a) struck “fifty-four” and added “eighty-eight” to have the text correctly reflect the listed numerical value for the fee.

§ 1306.4(b) struck “twenty-seven” and added “forty-four” to have the text correctly reflect the listed numerical value for the fee.

**Written comments regarding the original proposal:** Any written comments received during the original 45-day public comment period which began on February 2, 2024 and ended on March 18, 2024, with an extension to the public comment period ending on April 1, 2024 as published in the California Regulatory Notice Register 2024, No. 12-Z, March 22, 2024 (Notice File Number Z2024–0311–01), remain in the rulemaking file.

**Written comments regarding the first modified text, Addendum to the Initial Statement of Reasons, February 2024 California Consumer Price Index, Animal Blood Bank Program Expenses and Revenue 2024/25, and Economic and Fiscal Impact Statement (STD 399):**

Any written comments received during the first 15-day notice of modified text and documents added to the rulemaking file which began on June 6, 2024 and ended on June 20, 2024, remain in the rulemaking file.

**Written comments regarding the second modified text:** The second 15-day notice of modified text **begins on July 1, 2024 and ends on July 15, 2024.** All written comments are to be restricted to the most recent modifications as shown in the attached second modified regulatory text. The Department is not required to respond to comments received in response to this notice on other aspects of the proposal. All written comments previously submitted regarding this proposal remain in the Department's rulemaking file. All written comments received by **July 15, 2024** which pertain to the indicated changes in the second modified text, will be reviewed and responded to by Departmental staff as part of the compilation of the rulemaking file.
