2003 Secretary's Advisory **Committee on Fairs**

The Secretary's Advisory Committee on Fairs (SACF) advises the Secretary of the California Department of Food and Agriculture (CDFA) on issues related to the network of California fairs, the fair industry, and related public issues. The Committee is under the jurisdiction of the CDFA, is appointed by the Secretary of the CDFA, meets approximately two times per year, and may consist of up to 25 members. Members are qualified for service to the Secretary through their affiliations with California fairs, such as serving as the Chief Executive Officer (CEO), a fair Board Member, a Service Member, working in the fair industry, or an individual having interest and knowledge of a fair or agricultural community. Members are selected to provide a cross-representation of California fairs, industry members, and the public. Below lists the Committee members and respective affiliations.

Executive Summary

The following report presents the 2003/2004 Network of California Fairs Expenditure Plan to the Joint Committee on Fairs Allocation and Classification. The report also highlights fair successes during the 2002/2003 fair season.

2003/2004 Expenditure Plan Highlights

The 2003/2004 Expenditure Plan is designed to reflect a combination of ongoing program support and new concepts reflecting industry and economic trends. With the California Fairs Statewide Social Economic Impact Study complete the fair industry now has a valuable tool to educate California's citizenry on the true and irreplaceable value of California's fairs. Fair performance was significantly improved this year with all fairs receiving performance ratings of either Class A or B. There are no Class C rated fairs this year. Performance measures have been well received by the fair industry and are extremely important to fair management in identifying best business practices for fairs. A shift of funding to the Millennium Flex Program will give fairs more local autonomy and provide a more efficient environment for utilizing this important funding source.

California Fairs Statewide Social Economic Impact Study

This year the California Fairs Statewide Social Economic Impact Study was completed resulting in a report titled Fairs – Exploring a California Gold Mine. The report discusses the economic and social impacts of the fairs in detail and demonstrates their value to the communities in which they are located. The network of California fairs receive approximately \$30 million from the

license fees collected on horse racing gaming each year, however, California's return on investment of these funds exceeds expectations. Annually, the fair industry contributes \$2.5 billion in economic impact to California, creates nearly 28,000 jobs, and generates \$136 million in state and local tax revenues.

Fair Performance Ratings

This will be the third year of the fair performance ratings, which were developed to evaluate a fair's overall performance. The fair industry found this program to be extremely valuable to assist them in identifying the areas in which they excel and those areas that need improvement. Further, this program provides the ability to reward fairs that are following best business practices by giving them increased funds and flexibility to address their issues at the local level.

Results of annual audits and current performance ratings show that fairs are accountable and responsible. While fairs deliver entertainment and fun to their patrons, fair management, Board Members, the Division of Fairs and Expositions (F&E), and others involved in the financial success and long-term viability of the fair industry in California take the business side of fairs very seriously.

This year 74 percent of fairs earned Class A ratings and 26 percent earned Class B ratings. We are proud to announce that all Class C fairs from last year moved to a B.

Millennium Flex Program

Business and Professions Code (section 19620) creates a framework for administration of the network of California fairs, allowing for maximum autonomy and local decision making authority. Fairs have proven track records of responsible management at the local level and over the last four years there has been increased efforts to improve the structural integrity of fairgrounds.

With this in mind, F&E will provide local fairs additional responsibility for programming capital improvements. Beginning this year Major Maintenance Programs (MMP) and Americans with Disabilities Act (ADA) funding have been incorporated into the Millennium Flex Program.

The Millennium Flex program was established to provide additional funding to responsible fairs, for maximum flexibility at the local level.

This will allow for increased control and decisionmaking at the local fair level. F&E believes that the proper controls are in place to monitor this increased delegation of responsibility.

California's fairgrounds are the primary mobilization sites for the California Office of Emergency Services (OES). This year's Millennium Flex program includes a category to fund necessary enhancements to strategically located fairground sites for homeland security purposes. CDFA will work in consultation with the OES to determine the appropriate sights and needed improvements.

Millennium Flex funds will be distributed this year in the following three categories:

Category 1: General Millenium Flex Use

Category 2: Ongoing Fairgrounds Maintenance

Category 3: Homeland Security Projects

2002/2003 Achievements

F&E and the network of California fairs achieved a number of key successes this past year. Achievements from last year's plan include:

- F&E was the recipient of the first annual Service Member Business Partner Recognition Award at the 2003 Western Fairs Association Convention & Trade Show in San Diego. This award was given to F&E in recognition of outstanding leadership, vision, and commitment to the fair industry. Service members represent over 650 small to medium sized businesses that are independently owned and operated. These businesses are an integral part of the fair experience, providing food and beverages, rides, entertainment, and commercial exhibits.
- F&E developed and distributed the Network of California Fairs Board of Director's Overview, which outlines the roles and responsibilities for Board Members and fair staff; best business practices; fair funding sources; and the importance of strategic business partners. F&E conducted several workshops for new Board Members on their roles and responsibilities and the open meeting requirements (Bagley-Keene and Brown Act.)



- F&E worked proactively with the Department of General Services Real Estate Services Division (RESD) and the California Construction Authority (CCA) to develop a process for submitting, evaluating, preparing, and approving real estate transactions at fairs. The parties meet regularly to compare project task lists, prioritize projects and remedy outstanding items. This new approach has resulted in improved relations, increased productivity, reduced turn around time on projects, and fewer complaints from all participants.
- In 1989, the California Construction Authority (CCA) issued bonds to construct satellite wagering facilitiess on fairgrounds. The annual bond debt service payment of \$2.26 million is paid from the Satellite Wagering Account. In march 2003, the CCA executed a partial bond refunding of \$6.88 million to take advantage of lower interest rates, which will result in a net present value savings to the Satellite Wagering Account of \$200,000 over the remaining term of the refunded bonds. The maturity date of the refunded bonds is July 1, 2011.
- The California Grown campaign emphasizes our strong ties to the land and our neighbors; restores pride in our homegrown products and our work; and helps our economy

- and our California way of life. California Grown reminds all of us how important it is to look for and purchase agricultural products grown and produced in the Golden State. The campaign is a private-public partnership supported by the state and federal government as well as the hundreds of growers who provide Californians with food, clothing, shelter and fiber. The campaign is also working with hundreds of stores and retailers throughout the state to promote California agricultural products. The California statewide fair network is beginning to utilize the license plate logo among their service providers, booths and entertainment venues as well as in their advertising. The California fair industry is helping to remind Californians to Be Californian*. Buy California Grown.
- As part of our ongoing efforts to educate the public on safe food handling, F&E developed, produced and distributed bi-lingual signs to all fairs to encourage patrons to wash their hands after touching animals. At Maintenance Mania, the annual training conference for fair maintenance staff, fair maintenance workers constructed portable hand-washing stations for use at fairgrounds.



- F&E worked with the Governor's Office, the State Library and the California Arts Council to present The California Quarter project at four fairs in 2002. The State Fair in Sacramento, Antelope Valley Fair & Alfalfa Festival in Lancaster, Los Angeles County Fair in Pomona, and Big Fresno Fair in Fresno all featured a booth with handout materials that encouraged California's citizens to submit designs for the California State Quarter, which is to be minted in 2005.
- F&E worked with livestock industry leaders to provide training to livestock judges at the California Livestock Judges Conference. A measurable result of the Judges Conference are new standards for judging market beef and market goats which will be implemented in the 2003 fair season.
- F&E and the California Fairs programmed approximately \$9.5 million for capital improvement projects at fairs, including \$4.2 million in Americans with Disabilities Act (ADA) improvement at fairs to allow increased access for all fair attendees.

- Authority (CCA) to identify fairs to participate in the photovoltaic program. The objective of the program is to generate an alternative energy source, (i.e. solar) to reduce energy costs at fairgrounds and to contribute to the continued statewide efforts to address energy concerns in California. CCA and F&E worked diligently to identify funding sources for this program, which included utility company grants, F&E loans (interest free), private energy loans, and fair funding.
- F&E has been working with community groups from Oakland and San Francisco to bring back agricultural fairs in these communities. The fairs are currently classified as special events as they work to adopt their governance structures. The Oakland Fair was held as a one-day event in September 2002 and is scheduled again for 2003. The San Francisco Fair date has not yet been determined.



Introduction

This report presents the 2003/2004 Expenditure Plan to the Joint Committee on Fairs Allocation and Classification. This publication includes an overview of the network of California fairs, the roles and responsibilities of various state, county and private organizations, and a comprehensive program list explaining the full range of programs supported by the Expenditure Plan.

Authority

The California Department of Food and Agriculture (CDFA) provides oversight to the network of California fairs through the application of law, development and review of regulations, policies and procedures, and supervision of fiscal administration. Furthermore, Business and Professions (B&P) Code Sections 19620 and 19606.1 authorize CDFA oversight of the Fair and Exposition Fund and Satellite Wagering Account, respectively. B&P Code Sections 19621(c) and 19606.1(c) require the CDFA to prepare an annual expenditure plan for review and approval by the Joint Committee on Fairs Allocation and Classification.

Table 1 shows various types of expenditures authorized for each account.

The Division of Fairs and Expositions

The CDFA's Division of Fairs & Expositions (F&E), provides fiscal and policy oversight of the network of California fairs and ensures the best use of available funding and other services.

Fair Oversight

This oversight responsibility includes the following (B&P Code Section 19620):

- Manage and monitor the solvency of the Fair and Exposition Fund and the Satellite Wagering Account.
- Distribute available state resources to the network of California fairs for local (base) allocations, health and safety repair projects, major maintenance projects, revenue generating projects, pari-mutuel facility improvement, and other fair programs.

- Create a framework for administration of the network of California fairs, allowing for maximum autonomy and local decision making authority.
- Providing incentives to fairs to seek matching funds and generate new revenue from a variety of sources.
- Support continuous improvement of fair programs to ensure California fairs remain highly relevant community institutions.
- Ensure annual fiscal audits and biennial compliance audits are performed.

F&E provides varying levels of oversight depending on the fair type. Table 2 provides examples of the type of oversight provided to DAA's and non-DAA fair organizations:

Network of California Fairs

Overview

B&P Code Section 19622.1 defines a statesupported fair organization as any fair that conducts an annual fair and submits an annual statement of operations to the CDFA. The generic term of "fairs" refers to District Agricultural Associations (DAA's), county fairs, citrus fairs, and the California Exposition and State Fair.

The network of California fairs includes 80 fair organizations divided into four categories (the latter three are non-DAA organizations):

■ 54 DAA's – state government entities 52 active DAA's; 2 DAA's were deactivated during fiscal year 1997/98.

- 23 county fairs County government or notfor-profit organizations
- 2 citrus fruit fairs not-for-profit organizations
- The California Exposition and State Fair (Cal Expo) – a state agency

F&E has been working with community groups in Oakland and San Francisco to bring back agricultural fairs to these communities. They are currently classified as special events as they work to adopt their governance structures.

Fair Organization Classifications

Fair organizations are expected to operate within their annual budgets. In order to receive state funding, their budgets must first be approved by F&E.

To ensure equitable distribution of these funds, F&E established an allocation policy providing support to fair organizations within seven budgetrelated classification levels. The result is that the *smallest* fair organizations, those in levels I–IV, receive the largest annual allocation of horse racing license fee revenues (\$105,000–\$180,000). Level I, II, III, and IV fairs have annual operating budgets of less than \$3 million. Many of these fairs are located in small communities with minimal opportunities for sponsorships or increased attendance. The fairs are truly the heart of the community and maintaining state support is critical to their success. For some level I fair organizations, the annual allocation represents up to 70 percent of their annual budget. The largest fair organizations, those in levels V-VII, receive the smallest allocation (\$35,000-\$40,000), representing less than one percent of their annual budget.

Local (Base) Allocations for 2003/2004 are shown in Table 3 below.

Benefits of California Fairs

Fairs entertain, but they also educate people about each other and the contributions that all segments of our society make to California. Through this vital education comes the understanding, appreciation and social harmony so necessary for a healthy and productive society.

Fairs provide a focal point for community members to:

- Celebrate their heritage
- Compete in a variety of events
- Hold family reunions
- Display and view artwork
- Learn about other cultures
- Premier new inventions
- Showcase the best of California

In addition to providing facilities and activities for educational purposes and broad community services; fairs also provide valuable community activities such as the following:

- Field trips
- Agriculture in the Classroom
- Head Start programs
- Pre-school programs
- Before/after school programs
- Charitable activities
- Weddings
- Cultural events
- Concerts
- Auto shows

- Livestock events
- Farmers markets

State and local government agencies use fairs to disseminate vital information regarding the protection of California's natural, industrial, and agricultural resources. These public outreach efforts offer communities a first-hand look at California agriculture and the essential role of this \$30 billion a year industry.

As an added benefit, California fairs promote awareness of California's cultural diversity. Approximately 11 million people attended California fairs and approximately 33 million people attended all fairground events held in rural, suburban, and urban settings. These fairs attract people from various ethnic and age groups, creating a diverse cultural representation.



Emergency Shelter

Fairs provide a location for cultural and social interaction; as well as facilities necessary for shelter and emergency evacuation. Fairgrounds are invaluable to coordinate activities during emergencies such as earthquakes, floods, fires, and other natural or unnatural disasters. Fairgrounds have been used in many capacities during emergency situations; below are a few examples:

- Office of Emergency Services mobilization and emergency staging sites
- Evacuation centers
- California Department of Forestry fire mobilization locations
- Emergency preparedness training
- Temporary homeless shelters
- Red Cross staging locations
- Animal shelter during crisis (i.e., floods or fires)

California Fairs Statewide Social **Economic Impact Report**

In 2002, the California Department of Food and Agriculture's Division of Fairs and Expositions engaged the international firm of KPMG LLP to measure the social and economic impacts of the statewide fair system and to produce a report detailing their findings. The resulting report Fairs - Exploring a California Gold Mine demonstrates that the economic and job impacts of California fairs are significant. Further, cultural aspects of the fair industry add an intangible human element to the impressive quantitative findings. The report discusses these various impacts and concludes that for its investment, the return for Californians is invaluable. The fair network receives approximately \$30 million annually from a license fee assessed against wagers on horse racing. The following highlights from the economic impact study provides quantifiable answers to the question, "What is California's return on this \$30 million investment into the fair network?"

Economic Impact:

Fairs have a significant impact on California's economy.

- The overall impact of spending by all participants at fairtime and interim events resulted in a total economic impact on California of \$2.55 billion in 2002.
- Attendee direct spending at fairtime and interim events totaled about \$963 million in 2002.
- Annual income impact from attendee, fair organization and fair-related business spending exceeds \$791 million.
- Jobs created by fairs through direct employment and multiplier impacts reached nearly 28,000 in 2002.
- State and local governments collected an estimated \$136 million in tax revenues from fair-related activities.
- For each worker the fair organization and related business employs, an estimated 2.62 total jobs are created. For each dollar that economic participants pay their employees, an estimated \$2.10 in total income is produced.
- Each dollar spent by fairs and interim event participants generates an estimated 39 cents of additional spending in the state, for a total impact of \$1.39 per dollar spent.

Agriculture – A central feature of fairs is to educate the public about the importance of agriculture in California.

- Sixty-nine percent of fairgoers felt that they knew more about agriculture after going to a fair.
- Fairs are a critical part of the junior livestock program, which educates young people about the breeding, raising and grooming of farm animals. Junior livestock auctions at fairs grossed more than \$21 million, with more than 42,000 animals purchased by nearly 19,000 buyers in 2002. Students receive 95 percent of auction proceeds.

Community Groups – California's fairs are major venues for community groups and nonprofit organizations to raise money and awareness of their programs.

- In 2002, 730 nonprofit groups raised \$8 million dollars at California fairs for their community programs. Add in the \$21 million raised at junior livestock auctions, and a total of \$29 million was raised for community benefits.
- One nonprofit organization, the Turlock Lions Club, raises approximately 85 percent of its annual budget from fundraising events held at the Stanislaus County fairgrounds. Proceeds from these events go to fund scholarships for local high school students, eye exams and glasses for needy children, youth sport teams, youth attendance at camps for the hearing impaired, and school playground equipment.

Attendees – Californians love their fairs and fairground events.

■ Fair-time attendance exceeded 11.1 million in 2002, and interim events attracted another 21.6 million people. Total annual attendance on fairgrounds is almost 33 million people — roughly the same as California's population of nearly 35 million.

- Paso Robles with a population of 25,200 hosts the California Mid-State Fair that draws more than 475,000 attendees throughout the year. Ventura with a population of 110,000 hosts the Ventura County Fair that draws more than 721,000 attendees.
- The average visitor attends the fair 2.1 times per year and lives within 100 miles.

Fair-Related Businesses - provide many goods and services that are essential to the fair experience.

- In 2002, carnival companies generated \$41 million in total spending, \$18 million in personal income and \$2 million in state and local taxes.
- Fairtime and master concessionaires created \$131 million in total spending, \$66 million in personal income and \$10 million in state and local taxes. Attendee direct spending on food and beverages totaled \$120 million, which generated more than \$5 million in state and local taxes.
- Commercial exhibitors generated \$491 million in total spending, \$219 million in personal income and nearly \$17 million in state and local taxes. Attendee spending on commercial exhibitor merchandise totaled \$406 million, which generated \$32 million in state and local taxes.
- Entertainers at fairs created \$28 million in total spending, \$17 million in personal income and generated \$1.6 million in state and local taxes.

Social and Cultural Impacts:

Giving Back

While the economic impact of fairs is noteworthy, it is the social and cultural impacts of fairs that may leave the most lasting impression on Californians.


- Fairs provide a focal point for community members to celebrate their heritage, compete in a variety of events, hold family reunions, display and view artwork, learn about other cultures, premier new inventions, and showcase the best of California.
- Ninety-five percent of attendees agreed that the fair they attended provided worthwhile community benefits.

- More than 1.2 million people, 11 percent of total fair attendance, participated in fair events and organized activities such as shows, exhibit programs, stage performances and contests.
- Many fairs offer free tours to schools, free youth admission on certain days, and valuable educational experiences throughout the year.

Organizational Relationships



State Government

California Department of Food & Agriculture (*CDFA*) – A state agency responsible for the oversight of California's agricultural industry, including the network of California fairs.

Division of Fairs and Expositions (F&E) − Provides fiscal and policy oversight of the network of California fairs and ensures the best use of available funding and services.

California Horse Racing Board (CHRB) — Regulates pari-mutuel wagering, promotes the horse racing and breeding industries, and maximizes State of California tax revenues from horse racing. CHRB provides regulatory oversight to six privately owned racetracks, nine racing fairs, and twenty simulcast-only facilities.

District Agricultural Association (**DAA**) – Holds fairs, expositions, and exhibitions to bring to light various industries, enterprises, resources, products and highlight agriculture of the state.

California Exposition and State Fair (Cal Expo) — A state department in Sacramento responsible for holding the annual California State Fair, and exhibitions to highlight various industries, enterprises, resources, and products of the state.

County Government or Not-for-Profit County Fairs – Holds fairs to highlight a county's agricultural and natural resources.

Citrus Fruit Fairs – Holds annual fairs to celebrate the citrus fruit harvest.



Other Organizations

In addition to the CDFA, there are other organizations involved with fair operations and industry direction. An abbreviated description of each organization's major roles are described below:



Joint Powers Authorities (JPA) – Three JPA's have been formed in California to provide specified services to the fair industry. CDFA is a party to the joint powers agreement that authorized the formation of each of the following JPA's:

- California Authority of Racing Fairs (CARF) Provides legislative and operational support, and professional development services for its members, all of which are horse racing fairs; assists CDFA with site selection and development for satellite wagering facilities; manages the track preparation agreement; and recommends an annual Satellite Wagering Account and racing track improvement plan.
- California Construction Authority (CCA) —
 Provides financing, design, and construction
 services for health and safety improvements,
 satellite wagering facilities, and other projects on
 fairgrounds. The proceeds from revenue bonds
 issued by CCA may be allocated by the Secretary
 of CDFA to provide partial funding for such
 projects. With the Secretary's approval of proposed
 scopes of work and budgets, additional projects
 may be funded by the CDFA, or the fairs, and
 implemented by CCA.

• California Fair Services Authority (CFSA) — Administers risk-sharing pools (general liability, workers compensation, revenue protection and all-risk property) designed to protect the Fair & Exposition Fund and local fair organizations; provides safety programs, facility and carnival ride inspections; and provides purchasing, computer, employee benefits, and management services.

Trade Organizations – The following not-forprofit association provides services to the fair industry:

• Western Fairs Association (WFA)/ California Fairs Alliance (CFA) – Sacramento based trade association representing 76 of California's 80 fairs. Services include legislative advocacy, regional meetings, training, and an annual convention. Publications include a membership directory, mini date list, quarterly Fair Dealer magazine and Update newsletter.

Funding

F&E Funding Methodology

F&E uses the following methodology to administer funding from the Fair and Exposition Fund (F&E Fund) and Satellite Wagering Account. This methodology was established for use in the 2000/2001 Expenditure Plan and will continue to be used for the administration of 2003/2004 Expenditure Plan funding.

- Since the F&E Fund and Satellite Wagering Account are continuously appropriated, unencumbered reserves at fiscal year-end will be included in the total available resources in the following year's expenditure plan. Therefore, total expenditures may exceed current year revenue projections. Expenditures may also be adjusted to accommodate funding fluctuations among local assistance programs, upon approval by the Secretary of Food and Agriculture.
- Expenditure Plan program costs, such as program specific materials and supplies, that are "above and beyond" the funds available to sustain F&E's general operations (i.e., the Division's State operations budget for office and staff expenses) will be funded by the respective Expenditure Plan program budget (i.e., local assistance funds).

California's pari-mutuel wagering system was made possible by a constitutional amendment in 1933 to encourage agriculture, but principally as a means to generate income for the state and to fund safety and maintenance projects at California's state and local fairgrounds. During this time period, horse racing revenues were generated solely from live racing at California tracks, where state license fees generated from this activity were designated to support the network of California fairs.

Over the last six decades, technological advances have created alternative means of horse racing wagering, such as satellite wagering and advance deposit wagering. Satellite wagering facilities appealed to the network of California fairs due to the potential increase in horse racing revenue and subsequent increase in state license fees. As a result, funding received from live track racing was used to construct numerous satellite wagering facilities throughout California. The introduction of satellite wagering in California created a second source of revenue, including out-of-state license fees, available to the horse racing industry, the network of California fairs and the General Fund by broadcasting California races to other facilities throughout the satellite wagering system.

The chart below depicts the source of state license fees in 2001/2002 (in \$ Millions).



Fairs do not receive state General Fund money – A licensing fee on wagers placed at horse races provides vital supplemental funding for fairs.



Fiscal Trends

The California Horse Racing Board (CHRB) records indicate that the total amount wagered on horse racing has increased steadily since Fiscal Year 1995/1996, while state license fees available to fund the fairs have declined. The following charts show the inverse correlation between the total handle to the total state license fees available to fund the Fair and Exposition Fund and the Satellite Wagering Account.

Today, approximately \$40 million from state license fees are budgeted annually to support the network of California's 78 active county and agricultural fairs and the operations of the CHRB and F&E within the Department of Food and Agriculture.

It must be noted, however, that the total annual license fee revenue available to fund the \$40 million budget for California's fairs and expositions have been eroding over the past several years due to a decline in horse racing revenue that impacts the F&E Fund and legislation that has reduced state license fees significantly. These local entities receive no General Fund support; instead they rely on horse racing gaming for the majority of their budgets. While nearly 63% of Californians take part in some form of gaming, more consumer dollars in recent years have gone to the state lottery and Indian gaming. At the same time, horse racing license fees that support local fairs have dropped 61% in the last five years and 85% in the past decade.

Advance Deposit Wagering


In an effort to keep California's horse racing industry competitive, Assembly Bill 471 (Hertzberg) authorized advance deposit wagering (ADW) in 2001, which allows customers to deposit funds into accounts in order to wager online and over the telephone. During ADW's first 10 months of operation in 2002, \$156 million in total handle was generated, which represented approximately 4% of the \$3.6 billion in total handle generated during the same 10 months. As stated in CHRB's 2001–2002 Annual Report, "One of the ongoing questions about ADW is whether it generates new money or cannibalizes the handle by drawing customers away from traditional wagering facilities." According to the CHRB, "There was no evidence of cannibalization during the first 10 months of ADW." The CHRB continues to study this matter.

While the potential impact of ADW is yet to be determined, we do know that at this time the F&E Fund does not receive any state license fee revenue from this activity. Should bettors continue to move towards ADW as an alternative to the traditional wagering facilities, the future solvency of the F&E Fund could be at risk. As a result, F&E continues to monitor the trends closely.

\$40 Million Guarantee

In the event that state license fees generated and paid to the State (i.e. the F&E Fund and Kenneth L. Maddy Equine Research Laboratory on the campus of U.C. Davis) in any calendar year are less than \$40 million, Business and Professions Code 19616.51 statutorily requires racing associations and fairs to remit to the State, the amounts necessary to meet the \$40 million minimum payment. The CHRB is responsible for the

collection of this guarantee should it be needed. It is important to note that the total needs of the F&E Fund and the Equine Research Laboratory total approximately \$42.5 million, \$40 million and \$2.5 million, respectively. In the event the \$40 million guarantee is "triggered," the combined need of \$42.5 million will not be met. The guarantee payment distribution methodology under this scenario has yet to be determined.



Program Descriptions



Fair Success Stories

There are a number of fair industry achievements throughout the year due to the resourcefulness of dedicated staff, volunteer groups, and board members. Highlights of a few of this year's success stories are:

KERN COUNTY FAIR

South Chester Partnership: Family Resource Center In 2002, the Kern County Fairgrounds helped develop and donated the location for a year-round resource center to be utilized by underserved families in the community.



Family Resource Center

Why the Family Resource Center was Developed:

The Kern County Fairgrounds is situated in an economically depressed area of the city. The neighborhoods surrounding the fairgrounds are struggling to rebuild, but signs of poverty are reflected in the abandoned hotels, overgrown lots, and subsidized housing.

In the midst of social and economic blight, four schools struggled to meet the needs of their underserved students. A survey of parents in the area pointed to concerns and problems ranging from inadequate health coverage to gang activity. The following statistics were part of a report entitled "Healthy Start Needs Assessment Results 1999"

- One-third say they do not feel safe walking in the evening in their neighborhoods.
- One-third say it is not safe for their children to walk to school alone.
- Twenty-two percent stated that their property has been robbed or vandalized in the past year.
- More than one-third believe that there are gangs in their neighborhood.
- Twenty percent say they would use emergency room help instead of a doctor because they do not have health insurance for their children.

How the Kern County Fairgrounds Got Involved:

Surrounded by schools and already used as a safe haven for children, the Kern County Fairgrounds did not need to see the statistics to know that there was a community need.

Seeking a way to make a difference in the lives of neighborhood children, Mike Treacy, chief executive officer, attended a meeting of the South Chester Collaborative in December 1999. The main topic of the meeting was to discuss the possibility of the group applying for a grant from Healthy Start, a program of the California Department of Education that connects families to community resources and empowers them to meet their own needs.

The outcome of the meeting was an offer by the Kern County Fairgrounds to provide the essential piece for the project — a donated location for the family resource center with full-time operational support.

The Fairground's donation had a snowball effect, providing the impetus for funding from the Kern County Commission on Children, the California Endowment and the Healthy Start program.

What the Family Resource Center Does:

The goal was to create a safe haven in the neighborhood for children and their families by providing a number of services that would improve the lives of area residents.

Already the center is:

- Providing family literacy training and services
- Increasing after-school activities for hundreds of children
- Increasing education levels in adults
- Providing Case Management
- Increasing awareness of health care resources available to families
- Connecting families to home ownership opportunities



Community Involvement – A South Chester Partnership

The community outreach program has directly impacted the neighborhood and has placed the Kern County Fairgrounds as a key community partner and an agent for positive change in the community. The success of the project has been a collaborative approach, with support from the Kern County Network for Children, Community Action Partnership, Kern County Commission on Children, Bakersfield City School District, Kern County Superintendent of Schools, local churches and area businesses.

The Benefits of the Family Resource Center:

The resource center is available to all non-profits, churches and government agencies — creating a true collaborative atmosphere, which is not identifiable exclusively with one agency.

Activities/Services at the Family Resource Center:

- The family literacy center teaches parents how to instruct their children in their pre-school years so that they are ready to learn in kindergarten. Parents also can attend English as a second language classes and GED classes.
- An on-site computer lab gives parents and children assistance with learning how to use computers.

Results Achieved After First Year in Operation:

- Provided 250 families with basic commodities
- Enrolled 75 families in Healthy Families/ Medi-Cal
- Provided school uniforms for lower income families
- Contacted all 6th graders needing immunizations
- Initiated Community Clean-Up Days



A True Fair Success:

- More than 400 families and children were served in the first year alone
- The project is ongoing and fair management is hopeful that this example of successful community outreach can be duplicated throughout the country.

SANTA CRUZ COUNTY FAIR

Agricultural History Project

The mission of the Agricultural History Project (AHP) is to preserve the history of agriculture as practiced in the counties of Santa Cruz, San Benito, and Monterey. In doing so, it is their hope that future generations might understand and appreciate the practices and values of previous generations. They promote, through education, a public awareness of the economic, cultural, ethnic and historical significance of agriculture in the area.

The Agricultural History Project was conceived in 1986 and continues to evolve to this day. 2002 saw the project come full circle in many ways. Volunteers completed work on the Codiga Center and Museum and held a dedication ceremony. The

Living History Farm had its ground breaking; wheat was planted in its fields. A new tool exhibit was created in the Porter Building and the annual Santa Cruz County Fair showcased "Yesterday's Farm", where farm practices from the past are highlighted and visitors can glimpse farm life from days gone by. Agricultural archives are now being moved to and housed in the Museum.

The Agricultural History Project (AHP) currently has exhibits at their "Yesterday's Farm" featuring grains and grinding, early dairy photos and artifacts, saddles and tack, farming equipment, buggies and wagons.

The AHP conducts school tours every Thursday. Children learn the rich farming history of the area and participate in hands-on activities including:

- Milking an artificial cow
- Grinding corn
- Wagon Rides
- Planting and shelling corn
- Churning butter
- Pumping water with a hand pump

KINGS FAIR JUNIOR FAIR BOARD

Kid's Ag Education Center

The Kings Fair in Hanford counts among its greatest assets the Kings Fair Junior Fair Board. The Junior Fair Board was created over 40 years ago and began with only nine high-school age students. Currently, the Junior Fair Board is made up of between 34-36 high-school age students each year who go through a rigorous but fair application process. All high schools in Kings County are sent applications but most kids know by the 8th grade that they need to start getting ready to apply!

Once appointed to the Junior Fair Board students have multiple responsibilities. They continue the tradition of acting as ambassadors for the fair

during fairtime, raise funds for special awards given to exhibitors, work with the traditional Fair Board by attending professional meetings, and they run the Kid's Ag Education Center. The Kid's Ag Education Center was the concept of Junior Fair Board Advisors Loretta Toledo and Donna Paulo. They created a concept whereby schools could visit the annual fair and the children could tour the barns and stop at the center to learn something special about agriculture, all with the help of the Junior Fair Board.

Since its inception, the Center has doubled in size. The group has raised funds to support construction projects plus the addition of a classroom, which serves as a meeting place and a storage facility. In addition, the group raises money to purchase educational supplies for the Center. All operational expenses are paid for with funds raised by this group throughout the year. This self-sufficient group received a first place WFA Achievement Award for Best Agricultural Program in 1999. Since then they have raised over \$80,000 to promote the education center.

MAINTENANCE MANIA 2003

Maintenance Mania was held at The Big Fresno Fair from January 27–30, 2003. Over 100 participants from 33 fairs attended this event, which enables fair maintenance staff throughout California to come together for networking and training. Funding for the event was provided by the Division of Fairs and Expositions (F&E). Members of F&E, California Construction Authority (CCA), California Fairs Services Authority (CFSA), The Big Fresno Fair, and various maintenance staff from other fairs coordinated the event.

The event offered:

- Forklift training and certification
- Aerial platform training and certification
- Standardized Emergency Management Systems (SEMS) overview
- Chemical and pesticide application training (including law reviews and certification)
- Americans with Disabilities Act (ADA) requirements training
- Electrical inspections and preventative maintenance training.

This year, for the first time, a hands-on project benefiting the entire fair industry was the centerpiece of the event. Protection against an e-coli contamination is a big concern for the fair industry. In 2002, California's fairs expanded the use of hand-washing areas at specific locations on their fairgrounds to help alleviate this concern. Maintenance Mania hosted a hand-washing station "build-off" to produce a number of stations for the Network. Participants, in teams of two, built one hand-washing station each in the shortest amount of time while maintaining correct construction. Prizes were awarded to the winners of the competition.

This competition served a dual purpose of providing training to the participants in building a hand-washing station using an industryapproved design, while supplying 40 much-needed hand-washing stations to the fairs for use on their grounds. The design for these hand-washing stations was provided to the participants to take back to their fairs for use in building additional hand-washing stations.

EXOTIC NEWCASTLE DISEASE

Helping to Prevent Its Spread Exotic Newcastle Disease (END) is a contagious and fatal viral disease affecting all species of birds. It is one of the most infectious diseases of poultry in the world; it is so virulent that many birds die without showing any clinical signs, and a death rate of nearly 100 percent can occur.

PROGRAM BACKGROUND:

In 1971, a major outbreak occurred in commercial poultry flocks in Southern California. The disease threatened not only the California poultry industry but also the entire U.S. poultry and egg supply. In all, 1,341 infected flocks were identified, and almost 12 million birds were destroyed. The eradication program cost taxpayers \$56 million, severely disrupted the operations of many producers, and increased the prices of poultry and poultry products to consumers.

END was confirmed on October 1, 2002 in backyard poultry in Southern California. The Governor of California has declared a State of Emergency, the Secretary of the United States Department of Agriculture (USDA) has declared an extraordinary Emergency, and San Diego, Riverside, Los Angeles, and San Bernardino Counties declared local emergencies because of this serious outbreak. All birds in Southern California are under quarantine, no birds, bird products, or END-exposed materials can be moved from the area without a permit from the USDA.

How the Fairs Helped:

The Division of Fairs and Expositions, realizing the network of California fairs could assist with the fight to stop the spread of END, held an information session at the Annual Western Fairs Association the same day that Governor Davis declared a state of emergency. At this session the Division recommended that fairs discuss the option of canceling all avian exhibits at their 2003 fairs. F&E provided guidance to the fairs in the development of policies to cancel their shows. The fair industry rose to the occasion and went forward with voluntary cancellations of all avian shows. By canceling their shows the fair industry raised public awareness to the seriousness of the END outbreak and reduced bird movement throughout California. The fair industry was also well prepared when a statewide quarantine on poultry exhibitions was later issued by the Governor.

This cancellation meant that fairs would not have youth poultry shows, part of 4-H, FFA, and Grange activities at local fairs. Not wanting the youth to miss out on an opportunity to showcase their hard work in competitions many fairs developed alternative bird show competitive programs such as the Avian Bowl or re-directed young exhibitors to alternatives projects.
