The update focused on the Draft Water Resilience Portfolio (public comment closed on February 7th), the Administration's commitment to Voluntary Agreements for habitat and flow in the Delta and its watersheds; as well as the release of the Voluntary Agreement Framework and proposed governance structure.

The Secretary also provided updates on Virulent Newcastle disease (VND), food safety meetings within the leafy green industry, and the designation of the spotted laternfly pest as a research priority by CDFA's Pierce's Disease Control Program. The Secretary also updated the Board on the California Food for California Kids program which aims to incorporate more California produced food in school lunches.
