NOTICE OF THIRD POST-HEARING MODIFICATIONS RELATING TO RENDERERS,
COLLECTION CENTERS, DEAD ANIMAL HAULERS, AND TRANSPORTERS OF
INEDIBLE KITCHEN GREASE

NOTICE IS HEREBY GIVEN of proposed modifications to sections 1180(b)(21), 1180.1, 1180.13, 1180.15, 1180.28(b), 1180.32(g) and 1180.35(b), and Forms 79-005A, 79-012A(1), 79-012A(2), 79-015A and 79-019A. The Forms 79-012A(3) and 79-012A(4) have been stricken from the file as they were incorrectly included with the originally proposed text.

The modifications pertain to the originally proposed regulatory text for the Meat, Poultry and Egg Safety (MPES) Branch [formerly Meat and Poultry Inspection Branch; name change effective July 1, 2011] and documents as described in the Informative Digest published in the *California Regulatory Notice Register* on February 18, 2011 [Notice File No. Z2011-0208-14, Register 2011, No. 7-Z] relating to the Rendering Program. The Department is now providing notice of proposed modifications to the text and forms specified under Subchapter 2, Chapter 4, Division 2, of Title 3 of the California Code of Regulations. A copy of the forms and third modified text are enclosed.
