Paying Your Application or License Fee





Overview

Payment of your application fee is required before CalCannabis Licensing Division can start reviewing your annual application. Alternatively, payment of your license fee for your annual or provisional application is the last step in the process.

After you've paid your application fee and cleared up any deficiencies on your application (see the quick reference **Responding to Application Deficiencies**), CalCannabis will send your Designated Responsible Party an email or letter asking you to now pay your license fee.

Approval Notification

When your license application is approved, CalCannabis sends the Designated Responsible Party a letter notifying of the approval and reminding that the license fee must be paid in full before your license can be issued.

You can pay a fee several ways:

- Pay online through your CalCannabis account
- Print your invoice and pay cash in person at the Bureau of Cannabis Control in Rancho Cordova or Eureka.
- Pay by check or money order at the address listed on the sample document to your right – follow the other instructions listed as well.

Note: If you mail a check or money order for your **license fee**, no further action is required until your license is issued. Check back by logging into your account so you can find and print your license certificate.

CalCannabis Cultivation Licensing

This is the payment portal screen for credit card payment. Add your address information, which does not transfer from your application.

Enter your payment information and click **Submit**. You can pay with Visa or MasterCard.

Note: Paying by credit card requires a convenience fee for the payment processor of 2.99% of the application or license fee.

Return to the **My Licenses** list to print your receipt. If you submitted your **application fee**, your completed application is now submitted for review to the CalCannabis Licensing Division.

Alternatively, if you submitted your license fee, you'll receive an email or postal letter notification that your license is issued.

Payment Portal – Bank Transfer

Under **Payment Options** on the previous page, selecting **Pay with Bank Account** takes you to a different payment screen. Click **Submit Payment** to continue.





CalCannabis Cultivation Licensing

On the **Payment Method** screen, choose from **Personal** or **Business** account types. Click **Next**.



Payment Information

On the **Payment Information** page, enter any missing contact information and scroll to the bottom of the screen.

Under **Payment Method**, enter the name of the bank account owner, the bank account number, re-enter the bank account number, and finally enter the bank routing number.

Find your Certificate

Once your **license fee** is paid, you'll receive an email or postal letter notification that your license is issued. Return to the **My Licenses** list and click on your **Active** cannabis cultivation license to find and print your license certificate.

It's important to keep in mind that this step does not apply for submission of your application fee. This step is only applicable once your **license fee** has been paid in full.

Note: Do not click on your cannabis cultivation <u>application number</u> – the license certificate is only available with your active cannabis cultivation <u>license</u> <u>number</u>.
