


HLB Detection Updates


- Detection of an HLB+ tree at a residential property in Murrieta, Riverside County.
 - Prior site where CLas+ adult ACP was detected in July.
 - The detection led to an expansion of the current quarantine boundary.
 - No commercial grove within 3 miles from the detection site.
 - Biocontrol agents were released in the area in August and September.
- Multiple rounds of warrants were executed in Orange, Los Angeles, and Riverside counties to remove HLB+ trees from the refusal properties.
- A public meeting was conducted on October 28 to treat delimitation areas in Los Angeles, Orange, Riverside, and San Bernardino counties.

Central District

County ACP Detections

- Fresno County confirmed September 16, 2025.
 - One residential trap with approximately 10 adult ACP in northwest Fresno.
 - Find site treated on September 22
 - A second residential detection confirmed on September 25. One trapped adult and several live nymphs collected via survey.
 - 400m treatment area. A public meeting was held October 7, and treatment began October 16.
 - Tamarixia were released September 24, October 8, and October 22.
- Kern County confirmed September 26, 2025.
 - One residential trap with one adult ACP in McKittrick.
 - Treatment was completed on October 2. No additional ACP observed.
 - Tamarixia released on October 8.



Central District

Trapping Activities

- ACP detection and grove trapping activities are on-going.
- Fresno delimitation will be serviced by Citrus staff until December.

Biocontrol

Tamarixia continue to be released in Ventura County.


Survey Activities

- Citrus commodity began in October and will continue as weather permits.
- Residential multi-pest surveys are on-going.



Santa Paula, Ventura County

- The last reported positive HLB tree was on October 3, 2025.
- A public meeting was held October 29, 2025.
- Warrants are scheduled to be served on November 4, 2025.

ACP Detections – Santa Clara County

• 8 new detections since September 17, 2025 – expanded delimitation area

Trapping Activities

- Winter trapping to begin October in 17 counties
- Year-round trapping ongoing in 3 counties
- Delimitation Santa Clara County (570 traps)

Biocontrol

- Tamarixia releases ongoing in San Jose, Santa Clara County
- Average 5,000 to 6,000 released twice a month
