

## Asian Citrus Psyllid Quarantine Program

### Approved Treatment Protocol For Intrastate Movement Of Regulated Nursery Stock

Regulated nursery stock **must** be treated **UNDER REGULATORY SUPERVISION** with **both** a systemic (Table 1) and a foliar (Table 2) pesticide to move within the Asian Citrus Psyllid (ACP) Nursery Regional Quarantine Zone for the specified certification period. Tables 1 and 2 below list the products approved by the California Department of Food and Agriculture (CDFA) as quarantine treatments for the movement of host nursery stock within the nursery regional quarantine zone for the ACP State Interior Quarantine (CCR 3435).

It is incumbent upon the user to follow all label directions when using any of the products listed below for quarantine certification purposes. Apply product at label rates listed for psyllids. If psyllids are not listed, contact the ACP Program. **Please reference the California Department of Pesticide Regulation (DPR) website to obtain product and label information, including site use: [www.cdpr.ca.gov](http://www.cdpr.ca.gov).**

## Approved Treatment Protocol for Interstate Movement of Regulated Nursery Stock

Regulated nursery stock **must** be treated **UNDER REGULATORY SUPERVISION** with **both** a systemic (Table 3) and foliar (Table 4) pesticide to move within the area quarantined for ACP for the specified certification period or from the area quarantined for ACP as specified by Limited Permit. Tables 3 and 4 below list active ingredients for the interstate movement of host nursery stock for the Federal Domestic Quarantine for Citrus Greening and Asian Citrus Psyllid.

It is incumbent upon the user to follow all label directions when using any of the products listed below for quarantine certification purposes. Apply product at label rates listed for psyllids. If psyllid is not listed, contact the ACP Program. **Please reference the California Department of Pesticide Regulation (DPR) website to obtain product and label information, including site use: [www.cdpr.ca.gov](http://www.cdpr.ca.gov).**

**Table 3: Systemic Products (follow soil drench/in-ground application method)**

APHIS-approved systemic insecticide must be applied no more than 60 days and at least 5 days prior to shipment for Imidacloprid products, and no more than 20 days and at least 5 days prior to shipment for Thiamethoxam products

**Table 4: Foliar Products**

Foliar treatment must be applied no more than 14 days prior to movement.

### Active Ingredient

Bifenthrin

Chlorpyrifos

Dimethoate

Fenpropathrin

Imidacloprid/Cyfluthrin\*

*\*If using Imidacloprid/Cyfluthrin for interstate shipments, both Imidacloprid and Cyfluthrin must be combined in the same foliar product and used in conjunction with a systemic product from Table 3.*
