# <u>Update on Strategy 5-Outreach and Collaboration</u> <u>CPDPP Outreach Update</u>

#### Homeowner Outreach Activities

Natalie DeAngelo from Nuffer Smith Tucker (NST) presented the Homeowner Outreach activities and results. She shared that NST announced the December detections of *Candidatus Liberibacter asiaticus* (*C*Las) positive Asian citrus psyllid (ACP) in San Diego through CitrusInsider.org. With the help of the San Diego County Agricultural Commission (CAC), more than 20 stories related to detection were reported through news outlets, radio broadcasts, and online publications. Additionally, NST is working on continuous media releases. Last, the CaliforniaCitrusThreat.org website is now fully available in Spanish and being translated into Vietnamese and Chinese.

#### **Industry Outreach Activities**

NST, in coordination with Growers Liaisons (GL), facilitated online meetings with growers and industry members. Post-meeting surveys were provided to participants and their outcome will be discussed in future outreach meetings. New pages and information such as the "Fruit for Thought" blog are added to CitrusInsider.org and will be updated regularly.

#### **Elected Official Activities**

Natalie DeAngelo gave a brief update on upcoming activities. Informational materials on *Tamarixia* releases were shared in 15 cities through social media and newsletters. In-language media training will be provided for Santa Clara CAC staff.

#### **Upcoming Activities**

The 2019-2020 Fiscal Year annual report is being prepared. NST is also working with California Citrus Mutual (CCM) on conducting virtual meetings with packing houses. Additionally, an outreach article is being written for Citrograph Magazine. As part of the *Tamarixia* outreach program, an audio news release is being prepared in English and Spanish for radio stations statewide. Together with GLs, NST is working on creating customizable fliers for growers with more than 25 trees.

#### **Grower Liaison Update**

David Gutierrez gave an update on the GL working group. The group is developing two documents; one internal document to outline general responsibilities of GLs and the other document will outline the general responsibilities of the statewide coordinator.

#### **UC Outreach Update**

Monique Riviera stated University of California (UC) scientists will be taking part in a scientists' panel webinar. Additionally, she is working closely with master gardeners' groups. Moreover,

Monique stated she is working with the Science for Citrus Health Group to create a short video with tips and tricks for ACP and Huanglongbing (HLB) scouting.

Marcy Martin noted the Citrus Research Board (CRB) continuously updates Citrograph Magazine and its newsletters. Also, CRB provided webinars on ACP and HLB during the last year.
