National Dairy Commodity Prices Continue to Move Upward...

The minimum price of milk, established by the Department each month, is the price that dairy processors must pay for milk used to produce dairy products. National commodity prices, primarily butter, Cheddar cheese, nonfat dry milk and dry whey, are significant factors in determining the minimum milk price (See national commodities prices chart on page 2).

Compared to last month, the national commodity prices for Western Dry Whey, Grade AA Butter, Cheddar Cheese and Nonfat Dry Milk all increased, consequently milk prices increased: whole milk increased eight and six tenths cents per gallon; reduced fat milk increased six and one tenth cents per gallon; lowfat milk increased four and four tenths cents per gallon; and skim milk increased two and four tenths cents per gallon.

With the winter season underway, nationwide milk production continues to decline, with California showing decreased milk production for the first nine months of 2009. Holiday dairy product production is in full force with plants sending milk to the churn. Holiday orders are steady and retail sales are strong. Currently, fuel and feed costs at the dairy are slightly lower than the levels of the last few months, but remain steady.

The table below shows individual prices for the four types of fluid milk by container size and the price changes from the previous month. The prices listed represent the minimum price paid by processors for the milk only - no other processing costs are included.

Note: Pending the outcome of the November 9, 2009 hearing, the January 2010 Class 1 prices will be announced on or before December 22, 2009.
