

**Secretary Seeks Nominations for Positions on  
The Milk Producers Security Trust Fund Board  
(Nomination Forms Must Be Postmarked  
No Later than February 20, 2015)**

The Department is seeking nominations to fill a position on the Milk Producers Security Trust Fund Board of Directors. The position will represent co-operative management. This appointment will be for a three-year term of office. The term will begin on January 1, 2015 and expire on December 31, 2017.

The Board member to be replaced is:

- Ms. Skylar Ryll – Representing Co-operative Management

The Milk Producers Security Trust Fund Law provides that members can serve no more than three consecutive terms of office on the Board. Ms. Skylar Ryll resigned from the Board as of January 16, 2015.

The Board of Directors holds two regularly scheduled meetings each year; one is usually held in March and the other in September. When necessary, the Board may hold special meetings should there be a significant payment default by a processor that results in producer claims against the Trust Fund. Meetings typically run two-to-three hours.

*Persons interested in serving on the Board, or interested in nominating another person to serve on the Board should complete a Nomination Form (see next page) and mail it to: CDFA, Milk Pooling Branch, 1220 N Street, Sacramento, California 95814, and attn: Patrick Asagwara. To be eligible for appointment, the nominee must serve currently in the capacity of a co-operative management. Nomination Forms must be post-marked no later than February 20, 2015.*
