





■ Total California Cheese Production

California Cheddar, Monterey, and Mozzarella Production, 2000-2014, In Billion Pounds



- California total cheese production reached a record 2.42 billion pounds for 2014.
- Cheddar, Monterey, and Mozzarella cheeses accounted for approximately 85 percent of California's total cheese production in 2014.
- Mozzarella cheese represents more than half of all cheese produced in California.

National Dairy Situation & Outlook – USDA Estimates

Latest Data Available:

Monthly: USDA estimates overall milk production across the U.S. increased 3.1% in December 2014, compared to December 2013. USDA reports that California milk production decreased 0.1% compared to December 2013 (on 1,000 less cows and the same pounds of milk per cow). Among other western states, compared to December 2013, Arizona was up 4.5%; New Mexico was up 0.5%; and Washington was up 5.0%. Only one of the top 10 milk producing states reported a production decrease. The largest increase was reported by Texas at 9.7% growth in milk production (on 30,000 more cows and 50 more pounds of milk per cow).

Quarterly: For the fourth quarter of 2014 compared to the third quarter of 2014, U.S. milk cow numbers increased to 9.280 million head, milk production per cow decreased to 5,490 pounds; the net effect was a decrease in milk production to 50.9 billion pounds. USDA projects that for the first quarter of 2015 compared to the fourth quarter of 2014, milk cow numbers will increase to 9.290 million head, production per cow will increase to 5,660 pounds; the net effect would be an increase in milk production to 52.6 billion pounds.

Milk Prices

Comparing the fourth quarter of 2014 to the third quarter of 2014, U.S. average all-milk prices increased to \$22.73/cwt. USDA projects that for the first quarter of 2015, U.S. average all-milk prices will be \$18.85-\$19.25/cwt.; Class III prices will be \$15.60-\$16.00/cwt.; and Class IV prices will be \$14.20-\$14.70/cwt.

Utility Cow Prices

Comparing the fourth quarter of 2014 to the third quarter of 2014, average U.S. utility cow prices were down \$2.06/cwt. to a national average of \$109.21/cwt. USDA projects that utility cow prices will average \$105-\$111/cwt. in the first quarter of 2015.

California Data Summaries

COMMERCIAL PRODUCTION OF ALL MILK

Production of all milk on farms and ranches in California during December 2014 totaled 3.471 billion pounds, a similar amount produced during December 2013. For the twelve months ending December 2014, total milk production increased 2.6 percent as compared to the same period the previous year.

MANUFACTURED PRODUCTS

For the month of December 2014, as compared to December 2013, the total manufacture of butter decreased 11.0 percent; manufacture of nonfat dry milk for human consumption increased 26.2 percent; other dry milk products decreased 39.5 percent; manufacture of total cheese increased 4.0 percent, and manufacture of total frozen products increased 40.5 percent.

SALES OF CLASS 1 MARKET MILK

Total sales of Class 1 market milk products in California during December 2014 decreased 1.4 percent compared to sales during December 2013.


