**A. CALL TO ORDER**

**C. INTRODUCTION OF GUESTS & STAFF**

Kristin Macey announced the appointment of DMS Senior Environmental Scientist Samuel Ferris as CDFA/DMS Liaison to the Committee.

**D. REPORTS AND INFORMATION (Informational)**

a. Committee Purpose. Kristin Macey explained the formation of a weights and measures system in California, and how DMS became a part of CDFA. Kristin Macey explained the significant role that RSA play in ensuring this system works properly, to protect the citizens of California and the businesses that use commercial weighing and measuring devices. Kristin Macey gave a brief overview of the legislative change because of Assembly Bill 376 in 1999 and the regulatory change in 2001 that are the basis of the current legal requirements for RSAs doing business in California. Kristin Macey concluded with the history of the RSA Advisory Committee; how it formed and had two meetings in 2001 but was disbanded shortly thereafter, and CDFA's desire to conduct a review of DMS' RSA Program now that twenty years has passed.

**E. NEW BUSINESS (Discussion/Action by Committee)**

a. Election of Committee Chair. Each committee member introduced themselves and stated their qualifications. Kristin Macey then called for nominations. Lucian Stacy nominated Steven Cook. Sam Bayless nominated Branden Wooley. Tom Pisani also nominated Steven Cook. There was no discussion. Sam Bayless, Michelle Buran, Lynn Carmichael, Tom Pisani, and Lucian Stacy voted for Steven Cook. Steven Cook and Branden Wooley voted for Branden Wooley. Steven Cook was elected chairman of the RSA Advisory Committee by a vote of 5 to 2.

**F. NEXT MEETING AGENDA ITEMS (Informational)**

Kristin Macey reminded attendees that the California Code of Regulations, Section 4088 (d) provides for the frequency of meetings: "The Committee shall meet at the call of the chairman or the Department, or at the request of any four members of the Committee. The Committee shall meet at least once a year."

There was no opposition to having the CDFA Liaison use Doodle Poll to schedule future meetings and assist the Chair with receiving agenda items and creating the agenda.
