1. "Factory Audit" Pathway (EVSE) – (*Lucian Stacy*)
 - i. DMS Notice [D-25-01](#) EVFS Factory RSA Guidance (January 17, 2025)
 - ii. Define the boundary between "Maintenance" and "Repair." (BPC Section [12531 \(f\)](#)).
 - iii. Ensure RSAs retain authority over field maintenance despite factory self-certification.
2. New Regulation for Compressed Natural Gas Blended with Hydrogen – (*Lucian Stacy*) (*CCR Title 4, Sections [4192.1](#), [4192.2](#) and [4206](#)*)
 - i. Field experience updates?
 - ii. Is NIST Handbook 44 sufficient for the new blend?
 - iii. Exceptions needed?
 - iv. Identify any regulatory gaps for this fuel type.
3. [AB 660](#) (Irwin, Chapter 911, Statutes of 2024) "Date Labeling" Compliance on Food Products (July 1, 2026) – (*Lucian Stacy*)
 - i. Prohibits "Sell By" dates; allows "Best if Used By" (quality date) and "Use By" (safety date)
 - ii. RSAs service and program scales (deli/bakery/meat) that print these dates
4. CARB "[Advanced Clean Fleets](#)" (ACF) – Weight Truck Exemption – (*Lucian Stacy*)
 - i. The Lack of or will be expensive to procure: ZEV chassis for heavy-duty weight trucks (Class 7/8 with PTO for cranes).
 - ii. Specialty calibration vehicles not compliant: RSAs and County Offices.
5. [AB 8](#) (Aguiar-Curry, Chapter 248, Statutes of 2025) Hemp/Cannabis Licensing Merger
 - i. Will RSAs servicing hemp scales now require Department of Cannabis Control (DCC) background checks or badges?

- ii. Clarify licensing requirements.
- 6. Streamlining "24-Hour County Notification" (BPC Section [12515](#)) – (*Lucian Stacy*)
 - i. Inconsistent across county jurisdictions (fax, email, phone).
 - ii. Utilize DMS Online Portal as a single source of reporting.
 - iii. Allows DMS to gather data on the frequency of devices being placed in service.
 - iv. Automate county notification via this Portal rather than manual multi-county reporting.
- 7. Sealing Commercial Devices – (*Lucian Stacy*)
 - i. *Seal presses and audit trails – RSA number and year on press.*
 - ii. *Lead and wire seals required on audit trail devices?*
