**SUBJECT:** 2021 Business and Professions Code and Revision Index

The 2012 Business and Professions Code (BPC) and the Revision Index are now posted and available on the Division of Measurement Standards' (DMS) website at:

This year, additions and amendments to the Division 5 of the BPC were limited to Chapter 14, Fuels and Lubricants sections 13400, 13440, and 13531 that defines "dimethyl ether-propane fuel blend", requires dimethyl ether-propane fuel blends for use as motor vehicle fuel to meet the latest specifications set forth by the ASTM International and exempt propane fuel blends from certain display and advertising requirements.

## 2020 Business and Profession Code Revision Index

### BPC Division 5

[AB 2663 \(2020\)](#): Chapter 14 Sections 13400, 13440, and 13531 defines “dimethyl ether-propane fuel blend” and require dimethyl ether-propane fuel blends for use as motor vehicle fuel to meet the latest specifications set forth by the ASTM International.

### BPC Division 5

[SB800 \(2017\)](#): BPC Division 5 – Technical Clean-up in Chapters 2 & 5, sections 12103.5, 12204, & 12537, changed “director” to “secretary”

Chapter 2., section 12240.(r), (s), (u)(3)(A). Reference to Civil Code § 1936. Was repealed in 2016 and amended and replaced with § 1939.01. DMS anticipates that the legislature will amend Div. 5 § 12240 in 2019 to update the Civil Code reference.

BPC Division 5 – Chapter 6. Section 12606.1. (EDITORIAL) Added: Repealed by Stats. 1969 ch 1309 §2

### BPC Division 5 – Legislative Changes

[AB 347 \(2017\)](#): Chapter 2, section 12240. Update language in 12240 (l), (o), and (p)., and Section 12246., which extends sunset date January 1, 2022.

[AB 2632 \(2017\)](#): Chapter 6. Section 12606 and 12606.2. (c),(7). Regarding packaging and labeling: containers: slack fill.

[AB 2676 \(2017\)](#): Chapter 7. Section 12703.1., 12704., 12709. Extended additional application information, sunset date, and fees for junk dealers / recyclers.

[AB 2061 \(2017\)](#): Chapter 7 Section 12725.(c). Allows increase weight limit to 82,000 lb for near-zero-emission or zero-emission vehicles.
