

Automatic Temperature Compensation (ATC) for Retail Motor-Fuel Devices Proposed Changes to California Code of Regulations, Title 4, Chapters 1 and 7.

Notice of Informal Pre-Rulemaking Workshop

The California Department of Food and Agriculture (Department), Division of Measurement Standards, is conducting an informal pre-rulemaking workshop to develop proposed regulatory language pertaining to retail motor-fuel devices that are equipped with automatic temperature compensation (ATC). When installed and activated in a retail motor-fuel device, ATC is an automatic means for adjusting indication and registration of the measured product volume to volume at 15 degrees Celsius (60 degrees Fahrenheit).

Purpose

The purpose of this informal pre-rulemaking workshop is to provide stakeholders an opportunity to offer comments and suggestions on the proposed regulation that will modify, amend, and reject language in California Code of Regulations (CCR), Title 4, Division 9, Chapters 1 and 7. The proposed regulation is intended to provide clear guidance to equipment manufacturers and to owners/operators of retail liquid-measuring devices who elect to install and use automatic temperature compensated retail measuring equipment. This proposed regulation is permissive and does not require owners/operators of retail motor vehicle fueling stations to install and activate ATC in their retail motor-fuel devices.

The Department currently adopts by reference in CCR, Title 4, § 4000 the latest publication of the National Institute of Standards and Technology (NIST) *Handbook 44*, "Specifications, Tolerances, and Other Technical Requirements for Weighing and Measuring Devices," including Section 3.30. Liquid-Measuring Devices. The proposed

regulation will amend the NIST *Handbook 44* standards adopted by the Department to establish requirements for ATC when installed and used in retail motor-fuel devices.

Background

Like many other liquids, fuel experiences expansion and contraction with temperature change. A retail motor-fuel device may be equipped with an automatic means for adjusting the indication and registration of the measured volume of product to the volume at 15 degrees Celsius (60 degrees Fahrenheit).

State law requires the use of ATC for wholesale sales of gasoline or diesel fuel. Business and Professions Code § 13520 requires gasoline and diesel fuel distributers or brokers to invoice their customers for purchases of 5,000 gallons or more for a single delivery to a single location on the basis of temperature-corrected volume. Similarly, NIST *Handbook 44* Section 3.30. specifies that wholesale devices equipped with ATC are required to automatically adjust the delivered volume of motor-fuel to an equivalent volume delivered at 15 degrees Celsius (60 degrees Fahrenheit).

The Department is the only state agency responsible for weights and measures enforcement and authorized to promulgate regulations for measurement standards. Business and Professions Code § 12107 provides that the Department shall adopt NIST Handbook 44 tolerances, specifications and other technical requirements, except as specifically modified, amended, or rejected by regulation.

Currently, CCR § 4001 contains the California-specific exceptions to NIST *Handbook* 44. CCR § 4002 contains the California-specific additions to NIST *Handbook* 44. This proposed regulation will add further exceptions and additions for the use of ATC in retail sales of liquid motor vehicle fuels. The proposed regulation will also specify in CCR Chapter 7 what information is required on fuel price sign advertisements when temperature compensated sales are offered from a retail motor fuel location. This information is necessary to enable the public to make value comparisons and informed purchasing decisions.

Stakeholder Comments

Oral comments: The Department will accept oral comments during the informal prerulemaking workshop. All stakeholder comments and suggestions will be reviewed and considered by the Department as it develops formal regulatory language.

Written comments: The Department will accept written comments regarding this proposed regulation at the workshop and until 5:00 p.m. on December 12, 2018.
