**NOTICE OF MODIFICATIONS TO REGULATION TEXT AND ADDITION OF DOCUMENTS  
AND INFORMATION TO RULEMAKING FILE**

Pursuant to the requirements of Government Code §§ 11346.8 (c) and 11347.1, and California Code of Regulations (CCR) § 44, the California Department of Food and Agriculture (Department) is providing notice of changes made to proposed regulation text in CCR Title 4, Div. 9, Ch. 1 §§ 4001 and 4002, and Ch. 7 §§ 4200, 4201, 4206 and 4207.

In addition to the changes to the regulation text, the Department is providing notice of an additional document relied upon for this rulemaking:

- Supplement to the Revised Initial Statement of Reasons

The Supplement to the Revised Initial Statement of Reasons lists additional statutes in the California Business and Professions Code relevant to the proposed regulation and provides detailed necessity and specific purpose for each subsection of the modified regulation.

The modifications to the regulation text, including an incorporated by reference document, and the Supplement to the Revised Initial Statement of Reasons are proposed to correct deficiencies identified in the Decision of Disapproval issued by the Office of Administrative Law on August 14, 2017.

The written comment period for the modifications of the regulatory text and the Supplement begins on November 2, 2017 and closes at 5:00 p.m. on November 17, 2017.
