NOTICE IS HEREBY GIVEN that the Department of Food and Agriculture (Department) will convene to receive public testimony regarding its proposed regulation to establish fuel quality specifications for natural gas motor vehicle fuel, along with labeling and advertising requirements for the retail sale of natural gas motor vehicle fuels. The proposed regulation will amend sections 4001, 4002, 4140, 4201, 4202, 4203, and 4204 and adopt sections 4193, 4194, 4195, and 4206 of Title 4 of the California Code of Regulations.

The original 45-day public comment period for this regulatory action, which began June 24, 2016, is hereby extended and will end on August 11, 2016. Written comments may be faxed or e-mailed by 5:00 p.m., August 11, 2016 to the contact named in this Notice. All oral and written comments submitted during the public comment period will be included in the Department's official rulemaking file.

The public hearing will be conducted in accordance with Government Code section 11346.8 that allows the public to provide oral or written statements, arguments, or contentions. The Department may impose reasonable limitations on oral presentations. Video and audio recordings of the hearing will be made. Technical difficulties with recording equipment prior to or during the hearing are not cause for not holding or for terminating the scheduled hearing.

The Department will consider all oral and written testimony and comments received. The Final Statement of Reasons (FSOR) will include the Department's response to each comment. Any person may request and receive a copy of the FSOR after it has been reviewed and approved by the Office of Administrative Law as a part of the compilation of the Department's official rulemaking file.
