STORMWATER PERMIT INFORMATION HANDOUT

Effective January 1, 2014, the California Business and Professions Code Section 12703.1(a)(2), requires junk dealer or recycler weighmasters applying for or renewing a weighmaster license to furnish a statement indicating that the applicant has either filed an application for a stormwater permit or is not required to obtain a stormwater permit.

Preliminary inspection observations have determined that a stormwater permit may be required at your facility. The Division of Measurement Standards will follow-up on all non-compliances. If it is determined that the information you submitted on the weighmaster license application is materially inaccurate, you will be at risk of having your weighmaster license revoked.
