Dear Secretary Kawamura:

On behalf of the California Agricultural Commissioners and Sealers Association (CACASA), I am respectfully requesting your assistance with implementing a change to the minimum education requirements for candidates applying for a County Weights and Measures Inspector license. On December 7, 2007 CACASA voted (*see attachment A*) to forward a proposal, presented to the Personnel Standards committee, requesting that you approve the minimum education requirement of a four-year degree, in the same disciplines deemed appropriate for the Weights and Measures licenses. The change would create an equitable level of education as is required for a County Ag Inspector/Biologist license. Our proposal would require changes to CCR Sections 105 and 108 (*see attachment B*).

In recognition of what is involved with regulatory change, CACASA agreed at its recent February meeting to request that the proposed change be placed on the 2008 Rulemaking calendar as a way to expedite its implementation (*see attachment C*). It is generally felt that elevating the minimum education requirement for future Weights and Measures inspectors will provide valid options to County Agricultural Commissioners-Sealers through effective use of appropriate cross-training of Weights and Measures staff, the same as is currently practiced with cross-training of Ag Inspectors/Biologists.

We are hopeful that you would agree to the proposed change as it would alleviate a long-standing inequity in the education requirements for licensed County staff. If you have any questions or should require more information, please give me a call.

- I. Call to Order
- II. Minutes of August 8, 2007 <u>M/S/P</u> Approved.

III. Reports

- a. CDFA ~ Grizard:
 - i. Exam results went out last week on technical license exams, Deputy Exam results will be out the week of December 10.
 - ii. 400 people took the exams.
 - iii. Aileen introduced two personnel technicians of the Exam Unit, Paulette Montez, and Jody Vatner (recently hired).
 - iv. Commissioner/Sealer/Deputy written exams closing date for written is Dec. 28.
- b. ACASA ~ Gregory Gee:
 - i. Sacramento valley hosted a successful ACASA conference. They had speakers from CDFA, DPR, the Sacramento Co. District Attorney and a Placer County Board member, Dan Webb and others.
 - ii. Next conference will be hosted by the North.
- c. CASAP ~ *Grewal*:
 - i. CASAP hosted 2 professional development workshops at 2 locations.

- ii. 3 management exam workshops are pending.
- iii. Annual conference is again going to be held in Monterey on January 19 and 20. CASAP invites all CACASA members to attend.
- d. Exam Review ~ Niswander
 - i. CPS (Cooperative Personnel Services) has submitted a report to CDFA that provides a cost estimate to do a job study for exam relevancy. The report has been reviewed by the Subcommittee.
 - ii. See item IV. a., below, for details pertaining to the Exam Review Subcommittee's recommendation for changes to the Oral Exams.

IV. Unfinished Business

- a. Exam Review Recommendation ~ *Niswander:*
 - i. Tim Niswander led a discussion of the Exam Review Subcommittee's recommended change to this year's (2008) oral exams. The intent is to examine for skills and knowledge necessary to manage in county government. There was also discussion regarding whether to retain orals for Deputy Commissioner and Deputy Sealer, with the majority of area group representatives favoring retention at both levels (see attachment A).

The proposed changes were $\underline{M/S/P}$ to recommend, as presented, their adoption to the CACASA Board of Directors for recommendation to CDFA to take effect for 2008.

ii. There was also discussion regarding the length of time written examinations should be valid.

It was <u>M/S/P</u> to recommend to the Board of Directors to propose to CDFA that success in the written exam for Deputy, Commissioner, & Sealer be effective for 5 years instead of the current 2 years for purposes of applying for the corresponding oral exam.

- b. Deputy Oral Exam Status ~ *Niswander*
 - i. This item was concurrently covered by inclusion in the recommendation from the Exam Review Subcommittee and the subsequent motion in item IV, a., i., above.
- V. New Business
 - a. Minimum Qualifications (Biologist/Inspector) Proposals
 - Following discussion it was <u>M/S/P</u> to recommend to the Board of Directors that the proposal for minimum qualifications for County Agricultural Biologist/Inspector Exams, identified as the Coast/Sac Valley proposal, be forwarded to CDFA as a recommended adjustment to the current inequity in minimum qualifications (see attachment B).

- b. CASAP By-Laws ~ *Grewal/Niswander*
 - After discussion it was <u>M/S/P</u> to recommend to the Board of Directors that the California Association of Standards and Agricultural Professionals (CASAP) revised Constitution and Bylaws be approved (see attachment C).
- c. CACASA Handbook (pages 41-48) ~ *Niswander*
 - i. After discussion it was <u>M/S/P</u> to recommend to the Board of Directors that the CACASA Handbook be amended to replace pages 46 and 47, with a single page, to clarify the Special Achievement and Manager Awards Calendar procedure (*see attachment D*).
- d. Licensing/Examination Fees ~ Caseri/Carl
 - After discussion it was <u>M/S/P</u> to recommend to the Board of Directors that the proposal for modifying the Agriculture and Weights and Measures Licensing Examination/Renewal Fees, including Inspector/Biologist, Deputy, Commissioner, and Sealer, be forwarded to CDFA for its consideration (see attachment E).

CACASA Proposed Change to the Minimum Qualification for County Agricultural Biologist/Inspector Exam and Minimum Education for County Weights and Measures Inspector, as voted at its December 7, 2007 meeting:

To Request that the Secretary of the California Department of Food and Agriculture amend Title 3, CCR sections 105 and 108 as follows:

S 105. Minimum Qualifications- County Agricultural Inspector/ Biologist:

The following are the minimum qualifications for admission to the licensing examination for County Agricultural Inspector/Biologist:

Either I

Possession of one or more valid statewide specific category licenses as a County Inspector/Biologist or County Weights and Measures Inspector;

Or II

Education:

(No change to current wording).

S 108. Minimum Qualifications- County Weights and Measures Inspector:

The following are the minimum qualifications for admission to the licensing examination for County Weights and Measures Inspector:

Either I

Possession of one or more valid statewide specific category licenses as a County Weights and Measures Inspector or County Agricultural Biologist. and permanently employed as a County Weights and Measures Inspector or County Agricultural Inspector Biologist.

Or II

Education:

(1)Equivalent to graduation from college with major work in chemistry, physics, mathematics, engineering or other job related majors such as law enforcement commerce and marketing. Possession of a Bachelor's degree from an accredited four-year college with specialization in one or more appropriate disciplines in physical sciences, mathematics, engineering, law enforcement, commerce or marketing as determined by the Secretary. (Registration in a recognized college as a senior majoring in one or more fields will admit applicants to the examination but a <u>certificate license</u> will not be issued until graduation).

 - a. CDFA ~ Grizard:
 - i. Exam bulletins will be released February 8 on the CDFA county notification system.
 - ii. There will be an additional written Deputy exam given with the August exams.
 - Successfully passing management exams will qualify the individual to take oral exams for 5 years, instead of the 2 year period in the past.
 - iv. At the present time, exam fees remain unchanged.
 - v. CDFA (Grizard) will attend the Chico State job fair.
 - vi. CDFA is examining the written Commissioner, Sealer and Deputy exams and will report back at the spring conference.
 - vii. CDFA will supply Commissioners and Sealers with the specific unit requirements for new applicants to qualify for license exams, thereby giving the Counties the information necessary to assess applications.
 - viii. All License exam application forms are being converted to PDF files.
 - b. CASAP ~ *Niswander*:

- i. There was a good turnout of Commissioner/Sealers at the recent CASAP conference. Overall attendance was the largest ever.
- ii. The CASAP President will be invited to the Spring Conference.
- c. Exam Review Update~ *Niswander*
 - i. Jim Shattuck and Kevin Masuhara gave an exam review update for the upcoming round of management orals at the CASAP conference, additional sessions are being scheduled.
 - ii. The oral questions are now being developed.
- IV. Unfinished Business
 - a. Minimum Qualifications Recommendation ~ *Bray*
 - i. CDFA was encouraged to move forward with the minimum qualification recommendation from the CACASA winter conference.
 - ii. MSP to recommend to the Board of Directors that CACASA prepare a letter requesting that CDFA place CACASA's recommendation concerning minimum qualifications for Agricultural Biologist/Weights and Measures Inspector licenses on their 2008 rulemaking calendar.
- V. New Business
