CALL TO ORDER

The Disability Advisory Committee (DAC) Chair Peggy Blincoe called the meeting to order at 9:05 a.m.

ROLL CALL AND INTRODUCTIONS

EQUAL EMPLOYMENT OPPORTUNITY OFFICE UPDATE

AD-HOC COMMITTEE FOR OUTREACH UPDATES

The focus should be on disability awareness and the importance of accessibility. UPDATE ON DEPARTMENT WEBSITE ACCESSIBILITY

The DAC discussed whether an ad-hoc committee would be needed to review CDFA's DAC website for compliance purposes. Chair Peggy Blincoe reported that she will update the DAC website and it was determined that no ad-hoc committee would be necessary.

NOMINATION & ELECTION OF CHAIRPERSON

Chair Peggy Blincoe opened discussion for nominations for the new DAC Chairperson. Peggy Blincoe nominated Kapua Kahumoku to be the new DAC Chairperson. Following her acceptance of the nomination, Kapua was unanimously voted in by the DAC members to serve as the next DAC Chairperson

PUBLIC COMMENT

DAC Chair Peggy Blincoe discussed that Sean Coyle from the California Highway Patrol reached out to her regarding a DAC event at the State Capitol in October 2019. The discussion of whether the DAC would like a table at the event will be added to the next meeting's agenda.
