Approval of Minutes

- SK read an overview of the September 27, 2017 minutes
- PB corrected minutes stating that the DAC by-laws were passed during the September 27th meeting and were needing approval from Secretary.
- NW corrected minutes stating that national days of awareness were left from August meeting and were not discussed during September's meeting.
