On January 9, 2008, the Avocado Inspection Committee (AIC) added size 32 (05/08) and size 36 (5/22) to the Date/Size Maturity Releases for Lamb Hass, based upon a hedonic score of 6.0 (Liked Slightly) and 22.8 percent dry weight. Release dates were obtained from Dr. Mary Lu Apria's "Summary of Lamb Hass Results."

Concerns were voiced that sending early season Lamb Hass into the market where there is high quality Hass has the potential to disappoint customers. Mr. Wileman stated that Lamb Hass growers should be invited to the next AIC meeting to discuss this potential problem.

Mr. Ohannes Karaoghlanian requested a discussion on size 96. Since Mr. Karaoghlanian was absent, the discussion was tabled until the next AIC meeting.
