NOTICE OF A 15-DAY COMMENT PERIOD

Modifications to the Text of Proposed Regulations to Rulemaking File [Notice File No. Z2019-1121-01, Register 2019, No. 49-Z] related to direct marketing

NOTICE IS HEREBY GIVEN that pursuant to the requirements of Government Code Section 11436.8 (c), and Section 44 of Title 1 of the California Code of Regulations (CCR), the California Department of Food and Agriculture (Department) is providing notice of changes made to the action described in the Informative Digest published in the California Regulatory Notice Register on December 6, 2019 [Notice File No. Z2019-1121-01, Register 2019, No. 49-Z] which clarifies and makes specific the conditions of direct marketing at Certified Farmers' Markets.

The Department is proposing to modify the originally proposed text for Sections 1392.2(t); 1392.4(b); 1392.4(m); 1392.5(a)(2); 1392.5(a)(3); 1392.5(b)(1)(i); 1392.5(b)(4); 1392.5(b)(5); 1392.5(b)(6); 1392.6(a)(3); 1392.6(b)(1)(i); 1392.9(b); 1392.9(b)(2); Section 1392.10, Table A, #20; Section 1392.10, Table A, #40; Section 1392.10, Table B, #4; Section 1392.10, Table B, #13; and Section 1392.10, Table B, #15, of Title 3, Division 3, Chapter 1, Subchapter 4, Article 6.5 of the CCR.

Only those portions of the originally proposed text that are indicated by a <u>double</u> <u>underline or double strikethrough</u> have been modified. The remainder of the text remains the same as the originally proposed text.

The 45-day public comment period on the originally proposed text for this proposal began December 6, 2019 and ended at 5:00pm on January 21, 2020. The Department is now publishing a notice of a 15-day comment period on the modified proposed text. The purpose is to allow interested persons time to review the modifications to the proposed text and submit written comments. The 15-day public comment period begins **March 11, 2020 and ends on March 27, 2020 at 5:00 p.m.**

Please note: Any written public comments are to be restricted to the recent modifications as indicated in <u>double underline</u> or double strikethrough within the enclosed language. The California Department of Food and Agriculture is not required to respond to comments received in response to this notice on other aspects of the proposed regulation.
