**NOTICE IS HEREBY GIVEN** that Pursuant to the requirements of Government Code Section 11436.8 (c), and Section 44 of Title 1 of the California Code of Regulations (CCR), the California Department of Food and Agriculture (Department) is providing notice of changes made to the action described in the Informative Digest published in the California Regulatory Notice Register on July 6, 2018 [Notice File No. Z2018-0626-11, Register 2018, No. 27-Z] relating to the fertilizing materials violations matrix.

Additionally, pursuant to the requirements of Government Code sections 11346.8(d), 11346.9(a)(1), and 11347.1, the Department is providing notice that the document and other information which the agency has relied upon in adopting the proposed regulations has been added to the rulemaking file and is available for public inspection and comment. The document and information added to the rulemaking file is the Addendum to the Initial Statement of Reasons. This document is available for public inspection at 2800 Gateway Oaks Drive. Sacramento, CA 95833 from **June 18, 2019 through July 3, 2019** between the hours of 8:00 a.m. and 5:00 p.m.

The Department is proposing to modify the originally proposed text for Sections 2300.1, 2303, and 2322 of Title 3, Division 4, Chapter 1, Subchapter 1, Article 1, 4, and 6 of the CCR. The Department will continue the regulation process with the previously proposed regulation text, unless noted within the newly modified text. The Department is also proposing to withdraw the originally proposed text for Section 2320.2 of Title 3, Division 4, Chapter 1, Subchapter 1, Article 4 of the CCR.

The 45-day public comment period on the originally proposed text for this proposal began July 6, 2018 and ended at 5:00 p.m. on August 20, 2018. The Department published a notice of a 15-day public comment period on the revised proposed text on November 21, 2018 and ended on December 5, 2018. The Department is now publishing another notice of a 15-day comment period on the revised proposed text. The purpose is to allow interested persons time to review the modifications to the

proposed text and submit written comments. The second 15-day public comment period begins **June 18, 2019 and ends at 5:00 p.m. on July 3, 2019**.

**Please note:** Any written public comments are to be restricted to the recent modifications as indicated in **bold double underline** or **bold double strikethrough** within the enclosed language. The California Department of Food and Agriculture is not required to respond to comments received in response to this notice on other aspects of the proposed regulation. Italicized changes since the previous comment period are not substantive and the Department is not required to respond to comments relating to that text.
