CALIFORNIA CCA Educational Project Abstract/Summary

CCA educational outreach was successful in that certifications increased by 30% during the grant period with fewer dropouts.

CA CCA Abstract/Summary

Administration of CCA certification and CEU approvals were achieved in an efficient & timely manner by project partner CAPCA.

Introduction of an educational awareness outreach marketing effort came to fruition during the period and CA was recognized as fasting growing state for new CCA certifications. The leadership of the CA CCA organization achieved goals of expanding the program, elected to Chair the national program and recognized for nutrient expertise by CA regulatory agencies.
