2023 CDFA COMMERCIAL FEED REGULATORY PROGRAM

#### Certificate of Free Sale

A certificate of free sale is required by many foreign governments to allow entry of feed or fertilizer products into their country. The California Department of Food and Agriculture (CDFA) Feed, Fertilizer and Livestock Drugs Regulatory Services (FFLDRS) can provide a Certificate of Free Sale upon request and fee payment.

#### Fee Schedule

The cost for a Certificate of Free Sale and one (1) label is \$100.00.

Each additional label will require its own Certificate of Free Sale and will be charged the rate listed above for each label.

All fees are non-refundable.

#### **Process**

For commercial feed products, applicants must have a current California Commercial Feed license and a compliant feed label to receive a certificate. For fertilizer materials, applicants must have a current Fertilizing Materials license, product registration, and compliant fertilizer label. Certificates of Free Sale will not be issued for a livestock drug.

Any Certificate of Free Sale label(s) requiring revisions must be resubmitted within 60 days from the date of the request for changes. The file will be closed if the applicant does not respond within 60 days and fees paid will not be refunded.

To apply for a Certificate of Free Sale, login to your ExtraView account at <a href="https://inspect.cdfa.ca.gov/evj/ExtraView">https://inspect.cdfa.ca.gov/evj/ExtraView</a>, scroll down to the **CERTIFICATE OF FREE SALE** section and click "Add Certificate".




This will take you to the Certificate of Free Sale application form. All sections with red text are required and must be complete in order to submit the form.




You will notice "Product" is in blue. This option is only relevant to fertilizer products and is not required. For "Purpose of Request" you may include the country and any specific requests.

To upload a label, click on "Electronic Copy" and then click on the paperclip icon. A new window will open to allow the upload of the label.



You may either drag and drop or select a file from your computer. Once the file is in the box, select "Click here to upload files".




Alternatively, you may choose "Mail Hardcopy" and mail the label along with the printed confirmation page to the mailing address as noted below in the "Paying with Check" section.

You must certify the information is true and correct then hit submit. You will then return to the homepage and must go to your cart to pay.




### Payment


There are two ways to access your cart to pay for your certificate. You may select OK to the pop-up window shown below, or you can select the cart link found on your home landing page.



Accessing your cart will open a new window. Any items that need to be paid will be listed in this window under **ITEMS WITH FEES**. Check the box for all the items you will be paying for at the time.



Select "Calculate Total Due" and ensure the amount is correct. Select payment type. You may either pay with a credit card or check, however processing payment with a credit card is the fastest method.




#### Paying with Credit Card

If you select Credit Card, the credit card types accepted are American Express, MasterCard and VISA. Select the credit card type you are going to pay with and then hit submit at the top or bottom of the page.



A notification with instructions will appear at the top of the screen. Please follow the instructions.


#### Paying with Check

Select 'Check' as **Payment Type**, and then make the check payable to CDFA and send to the address listed below.



Once you submit, a notification with instructions will show at the top of your screen. Please follow the instructions by printing your confirmation page and sending with the

check to CDFA. If not uploaded electronically, be sure to mail the label as well.



## Final Steps

After payment, you will be returned to the homepage. If you paid with a credit card, the status of your Certificate of Free Sale will immediately show as "Pending Review". If mailing a check, the status will change to "Pending Payment". Expect 2-5 weeks for the payment confirmation to be received by the cashier, and then the status will change to "Pending Review".

The application and label will be reviewed by FFLDRS and if there are no revisions required, the Certificate of Free Sale will be mailed to the mailing address on the license. To request the certificate be mailed to a different address than appears on the license, note in the comments of the application where to mail the certificate.
