### **PROSECUTION UPDATES**

#### **California Bird Food Company – Modesto, CA**

On April 12, 2023, this case was forwarded to the Sutter County District Attorney's office, alleging failure to pay and operating without a license under the Food and Agricultural Code; misdemeanors.

#### **Kimberton Wines, LLC – Napa, CA**

On October 10, 2023, conference call with Napa County DDA Collins. Discussed violations of alleging failure to pay, operating without a license, and failing to produce records under the Food and Agricultural Code; misdemeanors.
