It appears that Tolliver Ranch Brands, LLC, has closed and ceased operations. DA's Office to conduct inquiry into current operations of Tolliver. # Fairwinds Estate, LLC

03/14/2025, pending review by Napa County DA's Office. Violation alleging failure to pay and operating without a license under the Food and Agricultural Code; Misdemeanors.

As of October 2025, Napa DDA advised no formal charges will be filed against Fairwinds Estate for operating as a Processor without a Processor license. The denial notice for the renewal of the Processor license was dated in January 2025, prior to this date, Fairwinds Estate, LLC was attempting to secure the documentation requested by MEB in order to renew this license. Given the dates, it is reasonable to conclude they believed they could purchase wine grapes during this pending renewal. No formal charges will be filed for outstanding wine grape payables. However, their office will continue to monitor, on a quarterly basis, payments made to these outstanding grower payables. Fairwinds Estate, LLC, stated, under penalty of perjury, they did not purchase CA farm products, namely wine grapes, in 2025. Therefore, not requiring a license under the Processors Law. Should they purchase CA farm products for processing or resale, they will submit a license application. Case closed.
