 - Approximately 50 individuals at each session

Supporting Comments

- Several organizations with experience and capacity were excited about regional flexibility
- Relationships at regional level are stronger than those with CDFA
- Some efficiencies gained
- Support growers better since some applications were DQ'd for minor reasons
- Open and quicker communications with applicant
- Quicker turnaround time

Comments in Opposition

- Added level of administration will remove funds from on-farm projects
- Selection of on-farm projects could hurt relationships between organizations and growers
- Challenges with geographic coverage
- Conflicts of Interest/Cronyism
- Limited resources or capacity to disburse funds to farms
- Folks appreciate the programs as they are currently; its difficult when the programs keep changing
- Farmers will be disappointed not be able to apply directly
- Minimum award of \$2 M will be too high

Common Themes and Questions

- Want standard application, review process across all the block grants so that the farmers have the same requirements
- Contracting process with farm operations should be standard
- What will be the administrative cap?
- How will administrative costs be differentiated from technical assistance costs?
- Need flexibility in flow of funding

Recommendations from Public and TA Providers For Block Grant

- Allow regional flexibility in program requirements
- Run the block grant solicitation at same time as a traditional format to compare
- Require a cross-review by third party for selection process for on-farm projects
- Consider hiring out the administration of funds to a single 3rd party

Other Considerations: Technical Assistance

Must work within requirements of AB 2377 (2018)

- Must make 5% of each appropriation available for TA
- \$5 M cap on TA per appropriation to each program
- Technical assistance providers are defined specifically
- Up to \$100,000 per year for TA
- 3-year limit on TA agreement

Technical assistance timelines in traditional framework

- Must hold stand-alone TA solicitation for each year's appropriation and allow adequate time for TA grant execution and outreach
- Since funds are appropriated in one-year increments, TA agreements are limited to cover that year

Other Considerations: CDFA Resources

Resource Limitations

- 5% historical admin cap spread across Department (OEFI, Grants, Financial Services, Information Technology, Public Affairs)
- One-time Funding
- Hiring Challenge and Lag Time

Number of grants to execute and invoices to process

• Timeline to execute grants also impact the project timeline – prompting revisions

CDFA-wide transition to AmpliFund

• Changes to application process and grant management for all
