

# Governor's Budget January 10, 2023

**General Fund Solutions: 90% of historic GF investments from 21-22/22-23 were protected**

## Funding maintained in its entirety:

### CDFA Programs\*

- Farm to School Incubator: \$90M
- California Nutrition Incentives Program: \$20M
- Senior Farmers Market Nutrition Program: \$1M
- Water Efficiency Technical Assistance: \$20M
- Livestock Methane Reduction Programs (AMMP/DDRDP): \$48M
- California Underserved and Small Producer (CUSP) Grant Program: \$30M
- Enteric Methane Reduction Research: \$10M
- Organic Transition Pilot Program: \$5M

## Funding reductions:

- Farm to Community Food Hubs: \$15M in 21-22 representing all funding
- Healthy Refrigeration Grant Program: \$8.9M reduction in 22-23, leaving \$11M\*
- Urban Agriculture Grant Program: \$5.8M in 21-22, leaving \$6.2M
- State Water Efficiency and Enhancement Program: \$40M in 22-23, leaving \$120M\* (\$70M available in next solicitation)
- Healthy Soils Program: \$15M in 22-23, leaving \$145M\* (\$70M available in next solicitation)
- Sustainable Cannabis Pilot Program: \$9M in 21-22 representing all funding
- Pollinator Habitat Program: \$15M in 22-23, leaving \$15M in 21-22
- Conservation Ag Planning Grant Program: \$22M in 22-23, leaving \$17M in 21-22
- Greenhouse Gas Reduction Research: \$5M in 22-23, leaving \$5M in 21-22
- Invasive Species Council: \$5M in 22-23, leaving \$5M in 21-22
- Beginning Farmer and Farmworker Training Program: \$5 in 22-23, leaving \$5M in 21-22
- Food Production Investment Program (CEC): \$10M reduction in 23-24, leaving \$65M
