PIPRA UPDATE

Alex Camacho from PIPRA (Public Intellectual Property Resource for Agriculture) reported on recent activities. Alex also said he met with CDFA's Information Technology staff regarding the transfer of the PD/GWSS research website at piercesdisease.org to CDFA.

Peter Matlock, Technology Facilitator, presented a report on the status of current research and the development of solutions to Pierce's disease.

Mark Greenspan, Researcher Grower Liaison, updated the Board and Task Force on his recent activities. This included meeting with the researchers and becoming more familiar with their research projects and the field trials.

RESEARCHER GROWER LIAISON CONTRACT RENEWAL

PDCP Special Assistant Tom Esser reported that the agreement with the Cooperative Agricultural Support Services which provided the services of the Researcher Grower Liaison would be ending on June 30, 2014, so a new agreement would be needed to continue receiving services beyond that date. GRAPEVINE FIELD TRIALS RECOMMENDATION

Steve McIntyre, Chair of the Product Development Committee (PDC), presented the recommendations of the PDC for continuing the grapevine field trials, as well as conducting associated research. After discussion, the Board voted to recommend continuing the grapevine field trials by adding time and funding to the seven current grant agreements established with the field trial researchers, and by supporting a project on disease assessment methodology. The new funding totals \$385,086 over the next three fiscal years.
