#### **RSAP MEMBERSHIP**

PDCP Special Assistant Tom Esser reported that Dr. Mary Beth Mudgett, the Chair of the Research Scientific Advisory Panel (RSAP), completed her term on the Panel and is no longer serving on the Panel. The new Chair is Dr. Nian Wang, from the University of Florida. Replacing Dr. Mudgett is Dr. Jeffrey Jones, University of Florida.

### PDCP FISCAL UPDATE

USDA PD/GWSS Program Director Beth Stone-Smith reported briefly on the federal funding for the Program. She said that the federal budget has not been signed yet, but there is a continuing resolution in effect until December 11, 2014. Additional funding might be needed for area-wide foliage treatments in Kern County due to funding deficits.

Board Chairperson Steve Schafer led the discussion on funding the area-wide foliage treatments. After some discussion the Board voted. Discussion about funding this treatment on a recurring basis would need to be held separately to address additional concerns and questions.

#### NURSERY REGISTRATION AND CERTIFICATION PROGRAM UPDATE

Board member John Crossland addressed concerns within the grapevine nurseries regarding pests and diseases of wine grapes including red blotch and leafroll virus. Joshua Kress, CDFA Senior

Environmental Scientist discussed the current changes to the Nursery Registration and Certification Program and how these changes will help address concerns like those within the nursery communities.

# **PIPRA UPDATE**

Alan Bennett, Executive Director of PIPRA, spoke about PIPRA and gave a brief update on current activities.

## 2015 REQUEST FOR RESEARCH PROPOSALS (RFP)

Tom Esser gave an update on the current activities of the RFP process. The RFP process has been changed to include red blotch, vine mealybug, and brown marmorated stink bug. He provided a handout which included time lines for the RFP process.

# PRODUCT DEVELOPMENT COMMITTEE (PDC) UPDATE AND PROPOSALS

PDC Chair Steve McIntyre gave an update on the recent activities of the PDC. He then presented a proposal by David Tricoli at UC Davis, to expand the range of grape genotypes that can be modified for use in research and product development.

The Board voted to recommend funding the research project by David Triocoli on grape genotypes. The total cost would be \$169,116 over the next four fiscal years.
