The Broomrape Research Subcommittee Meeting was convened at 10:01 a.m. by Committee Chairman, David Viguie, and introductions were made.

Research Update

The subcommittee received an update on a growing degree day calculator to help with scouting/rogueing/herbicide application timing. Economics and effectiveness of rogueing were discussed. A prototype of the tool was presented. The implementation potential for this tool was discussed. The committee continued discussion of scouting/rogueing timing, specifically in relation to exhibit G1 #7: "Establishment shall remove suspect broomrape plants upon detection." A potential issue with this language is that growers following endorsed BMPs could be found out of compliance if broomrape emerges between rogueing events. The committee discussed the possibility of establishing a window of time where the grower can rogue after a plant is found and remain in compliance. The notion of linking the compliance agreement to the BMPs for this specific item was discussed. California Tomato Research Institute (CTRI) staff gave an update on upcoming research projects for the subcommittee's review.

COMPLIANCE AGREEMENT

The subcommittee chair formed a task force to suggest to the Research Subcommittee, revisions to the compliance agreement exhibits, as well as propose a plan to transition to mandatory agreements. The task force will be made up of the following members:
