NEW WEIGHT:

APPLICATION DIRECTIONS: Each CDFA Bait Block weighs approximately one ounce.

NORWAY AND ROOF RATS: Apply 4 to 16 one-ounce CDFA Bait Block per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

HOUSE MICE: Place one 1-ounce CDFA Bait Block at each placement location. Space placements at 8- to 12-foot intervals. Placement of two 1-ounce pieces each may be needed at points of very high house mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of new feeding by house mice.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.
