

The emergency rulemaking action amended section 3435(b) in title 3 of the California Code of Regulations, to expand the quarantine area for the Asian Citrus Psyllid (ACP) *Diaphorinacitri* by approximately 13 square miles in the San Jose area of Santa Clara County and into Alameda County.
