All Trees Grown Outdoors	<u>Gypsy Moth</u>		<p><b>Must Be Certified from Area Under Quarantine:</b> All trees grown outdoors with and without roots</p> <hr style="border-top: 1px dashed red;"/> <p><b>Not Required to be Certified (Exempt):</b> Plants grown in a greenhouse year round</p>	<a href="#">CT, DE, DC, IL*, IN*, ME*, MD, MA, MI, NH, NJ, NY, NC*, OH*, PA, RI, VT, VA*, WV*, WI*</a>
All Pine	<u>Pine Shoot Beetle</u>		<p><b>Must Be Certified from Area Under Quarantine:</b> -Cut trees of all pine species -Nursery stock of all pine species -Raw pine material for pine wreaths and garlands</p> <hr style="border-top: 1px dashed red;"/> <p><b>Not Required to be Certified (Exempt):</b> Pine material which has been manufactured into wreaths or garlands</p>	<a href="#">CT, IL*, IN*, IA, ME*, MD*, MA, MI, MN, NH, NJ, NY*, OH, PA, RI, VT, VA*, WV, WI</a>
All Pine	<u>European Pine Shoot Moth</u>		<p><b>Must Be Certified from Area Under Quarantine:</b> All pine trees (with or without roots) with needles, shoots or buds</p> <hr style="border-top: 1px dashed red;"/> <p><b>Not Required to be Certified (Exempt):</b> -Pine boughs in wreaths -Up to 3 bonsai pine trees -Up to 3 rooted pines less than 3 ft -3 cut pines for indoor use -Cut pine branches = to 3 trees</p>	<a href="#">CT, DE, ID, IL, IN, IA, ME, MD, MA, MI, MO, NH, NJ, NY, OH, OR, PA, RI, WA, WV, WI</a>
Douglas Fir	<u>Phytophthora ramorum (Sudden Oak Death)</u>		<p><b>Must Be Certified from Area Under Quarantine:</b> -Cut douglas fir grown in Curry County, Oregon</p>	<a href="#">OR*</a>

\*Only certain counties are regulated
