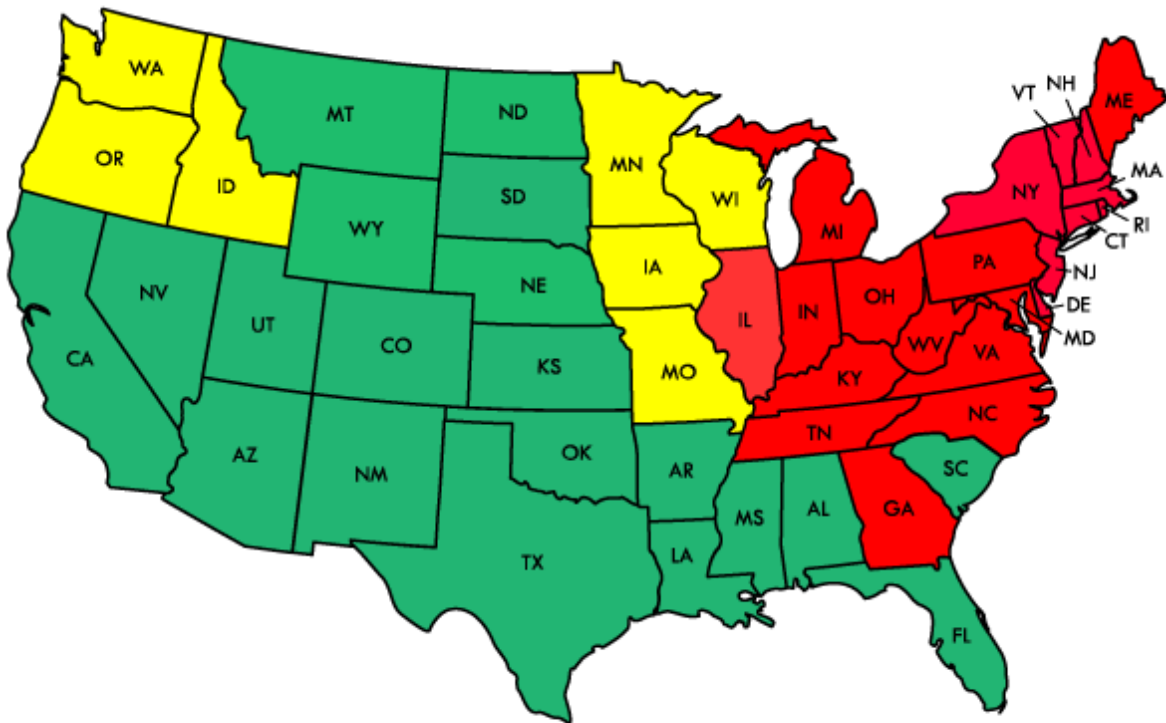

The following guide is for cut trees (no roots or soil), wreaths, and boughs **ONLY**.

Items with roots and soil may be subject to additional quarantine restrictions.

All items are subject to inspection at Border Protection Stations.



RESTRICTED	<p>The following states are under either a State Exterior Quarantine for Spotted Lanternfly and/or Federal Domestic Quarantine for Spongy Moth. All trees, wreaths, and branches are restricted from entering the State of California without certification:</p> <p>Connecticut, Delaware, District of Columbia, Georgia, Indiana, Illinois, Kentucky, Maine, Maryland, Massachusetts, Michigan, New Hampshire, New Jersey, New York, North Carolina, Ohio, Pennsylvania, Rhode Island, Tennessee, Vermont, Virginia, West Virginia</p>	
NOT RESTRICTED	<p>The following states have no restrictions on any species of cut trees, wreaths, and boughs:</p> <p>Alaska, Arizona, California, Florida, Hawaii, Kansas, Louisiana, Montana, Nebraska, Nevada, North Dakota, Oklahoma, Wyoming</p> <p>The following states do not require certification, but are subject to inspection at destination:</p> <p>Alabama, Arkansas, Colorado, Mississippi, New Mexico, South Carolina, South Dakota, Texas, Utah</p>	
SOME RESTRICTIONS CONTACT ORIGIN STATE DEPARTMENT OF AGRICULTURE FOR MORE INFORMATION	<i>Pinus</i> sp. Trees	<p>The following states are under a State Exterior Quarantine for European Pine Shoot Moth and require certification for all species of cut trees/branches of <i>Pinus</i> sp. only (*See exemptions below): Idaho, Iowa, Missouri, Oregon, Washington, Wisconsin</p> <p>*The following articles are exempt from certification requirements:</p> <ol style="list-style-type: none">1. Pine boughs in wreaths.2. Noncommercial shipments not exceeding 3 in number of:<ol style="list-style-type: none">a. Cut pine Christmas trees for normal indoor use.b. Cut pine branches, not to exceed the equivalent of 3 pine trees
	Douglas Fir Trees <i>(Pseudotsuga menziesii)</i>	Douglas Fir Trees (<i>Pseudotsuga menziesii</i>) grown in Curry County, Oregon require certification for Federal Domestic Quarantine for Phytophthora ramorum .
	All Other Species of Cut Trees	<p>The following states include counties under a Federal Domestic Quarantine or State Exterior Quarantine. For requirement information, see their state agricultural department websites:</p> <p>Minnesota and Wisconsin</p>
