#### Registering for a Webinar on GoToWebinar

- 1. Click the Registration URL, provided on the notice and agenda, to open the registration form.
- 2. Fill all required fields including first name, last name and e-mail address. Accept the organizer's webinar disclaimer by checking the box, then click **Register**.

#### Joining the GoToWebinar

- 1. To join a webinar via your computer:
  - a. Click on the webinar link received in the confirmation e-mail.

A new window will appear with the pop-up message "Open GoTo Opener?" Click **Open GoTo Opener**.

b. Call the toll-free number and, when prompted, enter the 9-digit access code followed by the pound sign. A unique audio pin will be displayed after joining the webinar. Enter the pin followed by the pound sign. You will be muted by default.

**Self-mute when not speaking to prevent background noise**. If using a phone for audio, click "Mute" on the phone. If using computer audio, select the microphone icon on the webinar application as shown below:



You will be informed when the broadcast has started.

**Note**: While GotoWebinar has the option for computer audio, it is recommended that all attendees use the phone audio feature. If you use the computer speakers with a microphone, there will be significant feedback. If a telephone is not an option, a computer headset with microphone is recommended.

- 2. To join a webinar via your Apple or Android Device:
  - a. Download the free **GoToWebinar** app for iOS or on Google Play app store.
  - b. Sign in the app or select "Join with Webinar ID" at the bottom of the screen. You will need to connect an existing LinkedIn, Facebook, or Gmail account to sign in.
  - c. If signed in, tap the **Join URL** link found in the webinar confirmation email to automatically launch the app.
  - d. If not signed in, copy the 9-digit webinar ID found at the bottom of the webinar confirmation e-mail and enter the ID.

#### Providing Questions and Comments during the GoToWebinar

- 1. All attendees will remain muted until public comment period for each agenda item. If you have a question or a comment on an agenda item, there are a few ways you can provide it.
  - a. Write a question/comment in the Questions pane:
    - i. Expand the "Questions" pane and type in your question/comment. Click "Send Privately" and the organizer(s) will be able to view it.
    - ii. The organizer(s) will see your question/comment and it will be read out loud.
  - b. Write a question/comment in the Chat pane:
    - i. Expand the "Chat" pane and enter a question or comment. Click "Send" and the organizer(s) will be able to view it.
    - ii. The organizer(s) will see your question/comment and it will be read out loud.
  - c. "Raise your Hand"
    - i. Click the "Raise your Hand" tool at the top left of the GoToWebinar application. The hand icon near your name will be raised and the organizer(s) will be notified.
    - ii. The organizer(s) will announce your name and unmute you (if needed) to provide your question/comment.
