Participation in the California Department of Food and Agriculture, Nursery Services, California Grapevine Registration and Certification Program is voluntary. The Department is responsible for processing applications, maintaining records, approving planting sites, inspecting and/or collecting samples from participant's primary and secondary increase blocks and certified nursery plantings, and preparing inspection reports. The current fees have not been supporting the existing workload of the program. The purpose of this meeting is to provide an update to stakeholders and receive feedback on the new fee structure for application processing and grapevine inspections.

The following fees will be due for the 2025 growing season.

Fee Type	Old Fee Structure (effective 2010)	New Fee Structure (effective 2025)
Application	\$200 per application	<b>\$250</b> per application
Increase Block	\$50 per acre or portion thereof	<b>\$140</b> per acre or portion thereof
Certified Block	\$120 per acre or portion thereof	<b>\$170</b> per acre or portion thereof
Greenhouse	\$100 PLUS # Sq. Ft. at \$100 per each additional 20,000 Sq. Ft. or portion thereof	<b>\$140</b> PLUS # Sq. Ft. at <b>\$140</b> per each additional 20,000 Sq. Ft. or portion thereof
